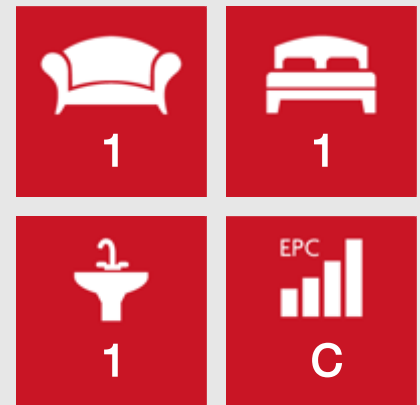

Floorplan

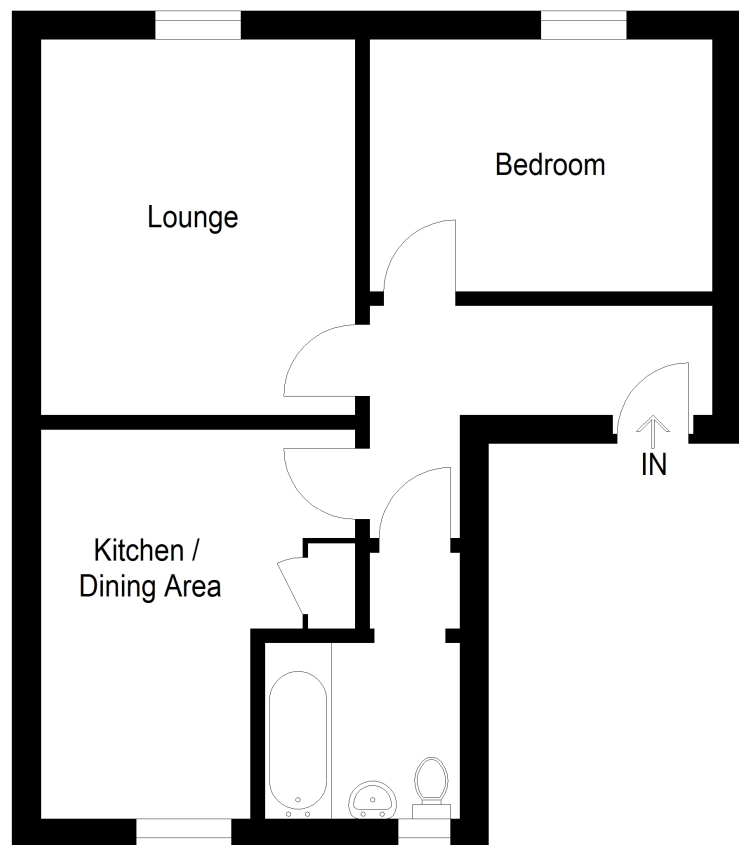
