



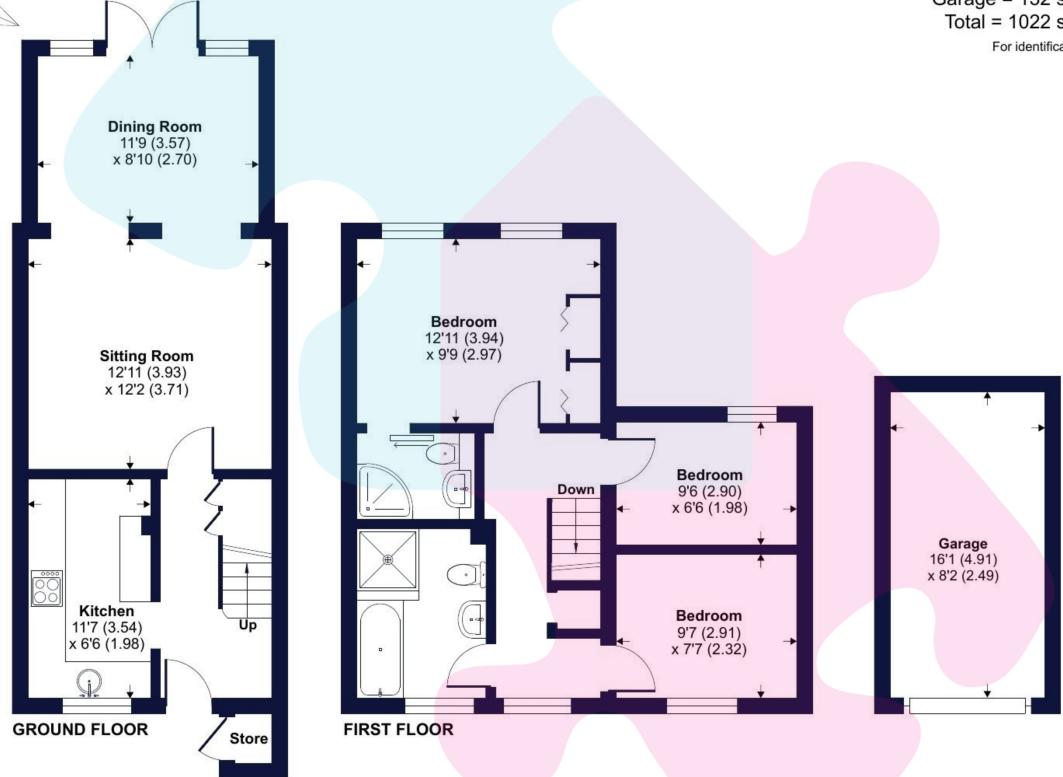

The property overlooks woodland, is only a few minutes walk to the Lightwater Country Park and the local Connaught Park School has recently been given an 'Outstanding' rating by Ofsted.

In terms of accommodation, there are three bedrooms, a stylish en-suite shower room and built in wardrobes to the main bedroom and a spacious family bathroom with separate shower cubicle and underfloor heating. Downstairs the kitchen overlooks the woodland to the front, the living room is of a generous size and flows into the orangery area which has both dining and study uses with patio doors leading onto the garden. Please note the entire ground floor has zonal underfloor heating.

The rear garden has been landscaped with both patio and artificial lawn areas and has a gate leading to the parking area and garaging. The front garden is a large area and is also laid with artificial lawn and has quite a charming courtyard feel.
