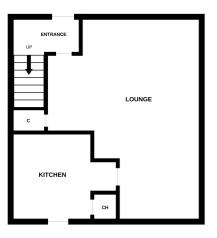




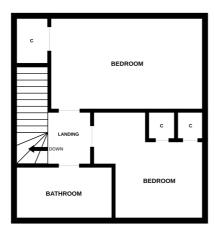


Floorplan
