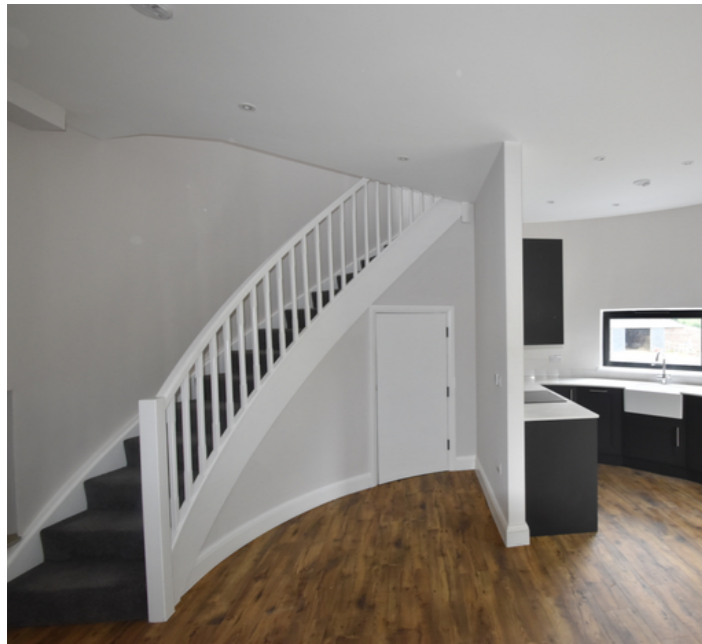

### Property Summary

The Oast House forms one part of a larger converted oast house. Found in rural Bearsted, tucked away just off a private lane, it is handily positioned for both the M20 and local railway station.

The conversion has been undertaken to a particularly high standard and will provide most comfortable accommodation with views over open countryside and farmland.

Downstairs there is an open plan living space/kitchen area in the roundel with a fully fitted kitchen with appliances. Upstairs there is a large landing area, bedroom with stunning views and spacious bathroom.

The Oast House benefits from double glazing and using an air source heat pump, underfloor heating. There are also solar panels and an electric vehicle charge point.

There is an attractive private courtyard garden to the front along with a parking area and a communal residents garden.

An early viewing comes most recommended.

19' 2" x 16' 4" including kitchen area (5.84m x 4.98m) Circular shaped room. This area consists of what was formerly the roundel.

Double glazed window. Underfloor heating. Staircase to first floor. Understairs cupboard. Leads through to

### Kitchen Area

9' 0" x 8' 0" (2.74m x 2.44m) Circular shaped room. Double glazed window. Range of contemporary base and wall units. Quartz worktops. Butler style sink unit. Bosch electric oven and hob with extractor over and decorative splash back. Integrated fridge/freezer. Integrated slimline dishwasher and integrated washing machine. Downlighting. Underfloor heating.

## First Floor

### Landing

Double glazed feature round window. Potential storage area.

### Bedroom One

17' 10" max to wardrobe door x 10' 2" max (5.44m x 3.10m) Semi circular room. Five double glazed windows to front with panoramic view over farmland. Double wardrobe cupboard. Underfloor heating. Carpet. Cupboard. Vaulted ceiling. Exposed beams.

### Bathroom

Suite of concealed low level WC and vanity hand basin. Offset large bath with separate shower unit with two shower heads. Chrome towel rail. Downlighting. Extractor. Half tiled walls.

Courtyard patio area to front.

### Communal Garden

There will be a communal garden area beyond the parking area.

## Parking Area

There will be one parking space per tenant. There is also a vehicle electric charge point.

**What Fees We Can Ask You To Pay**

**BEFORE YOU MOVE IN:**

•Holding Deposit of £150.00 (which must not equate to more than one weeks' rent) This is to reserve the property. Please note, this will be withheld if any relevant person (including any guarantors) withdraw from the Tenancy, fail a right to rent check, provide materially significant false or misleading information or fail to sign their tenancy agreement (and/or deed of guarantee) within fifteen calendar days (or other deadline for agreement as mutually agreed in writing).

•Security Deposit of five weeks' rent. This covers damages or defaults on the part of the Tenant during the Tenancy.

**DURING YOUR TENANCY:**

• Unpaid rent: Interest at 3% above the Bank of England Base Rate from rent due date until paid in order to pursue non payment of rent. Please note: This will not be levied until the rent is more than fourteen days in arrears.

• Lost keys or other security devices: Tenants are liable to the actual cost of replacing any lost key(s) or other security device(s). If the loss results in locks needing to be changed, the actual costs of a locksmith, new lock and replacement keys for the tenant, landlord and any other persons requiring keys will be charged to the Tenant. If extra costs are incurred there will be a charge of £15.00 per hour (inc.VAT) for the time taken replacing lost key(s) or other security device(s).

• Variation of contract (Tenant's request): £50.00 (inc.VAT) per agreed variation. To cover the costs associated with taking Landlord's instructions as well as the preparation and execution of new legal documents.

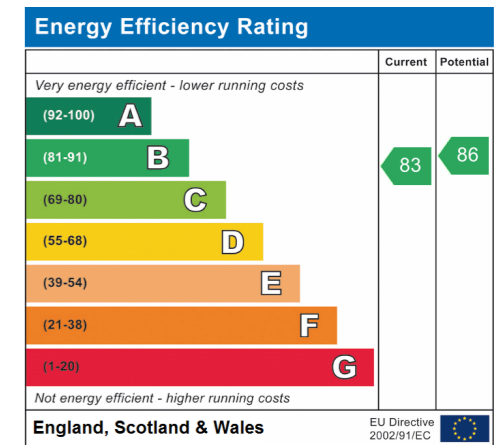
• Change of sharer (Tenant's request): £50.00 (inc.VAT) per replacement Tenant or any reasonable costs incurred if higher. To cover the costs associated with taking Landlord's instructions, new Tenant referencing and right to rent checks, deposit registration as well as the preparation and execution of new legal documents.

• Early termination (Tenant's request): Should the Tenant wish to leave their contract early, they shall be liable to the Landlord's costs in re-letting the Property as well as all rent due under the Tenancy until the start date of the replacement Tenancy. These costs will be no more than the maximum amount of rent outstanding on the Tenancy.
