Ground Floor

Entrance Hall

Radiator, solid wood flooring, stairway to galleried first floor landing, double glazed door to front, open plan to Kitchen, doors to Cloakroom and Lounge.

Fitted Kitchen

Established gardens with lawned areas and paved sections forming a paved seating area and path to the rear garden gate. Driveway of the side leading to a Garage.

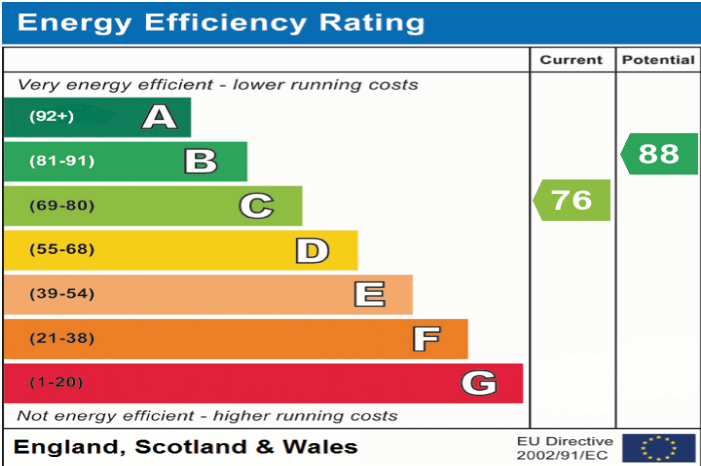

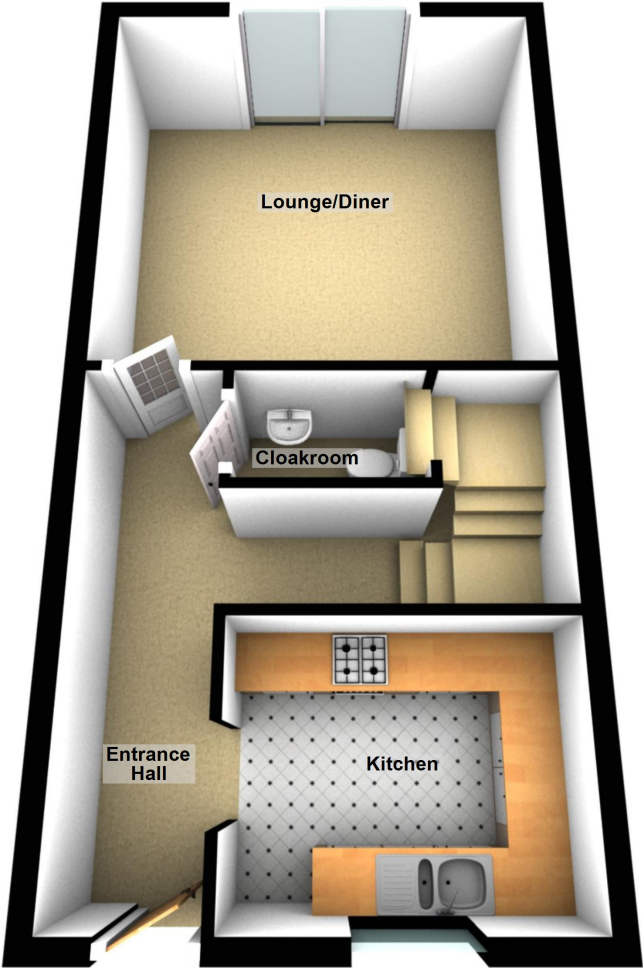

Services: Mains water, drainage, electricity and gas are believed to be connected to the property but purchasers are advised to satisfy themselves as to their suitability.

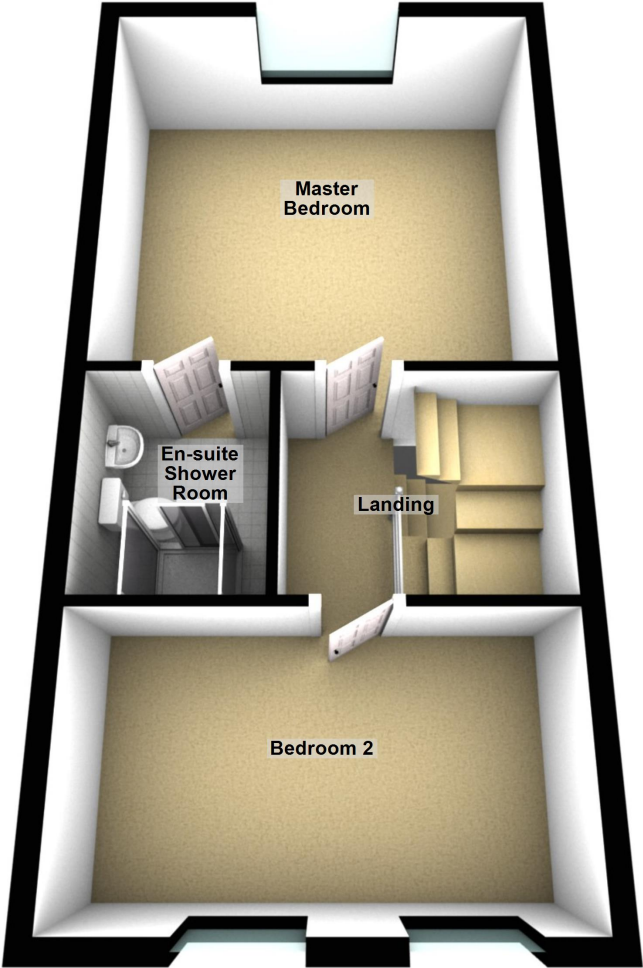

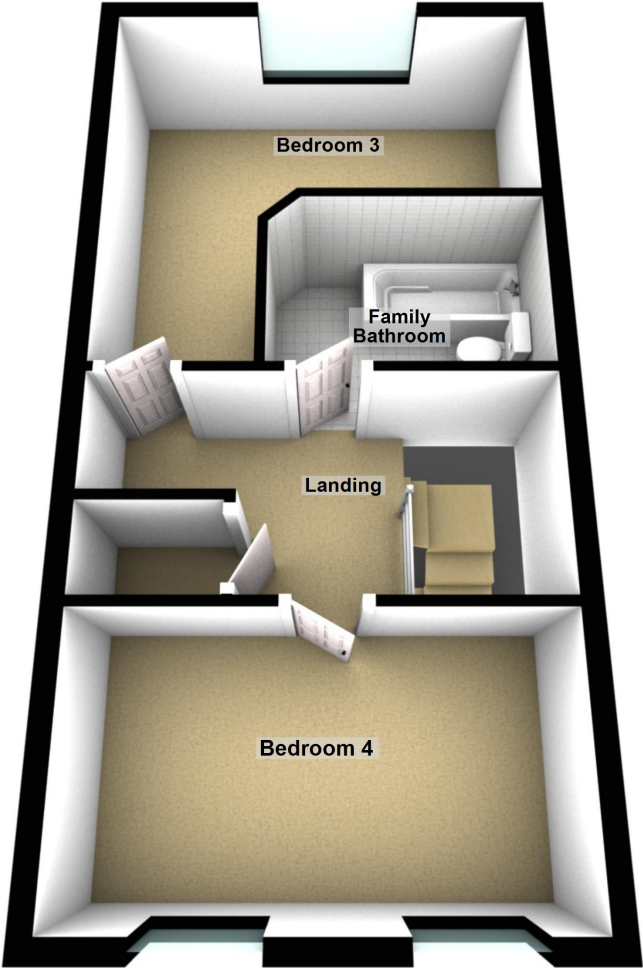
Ground Floor

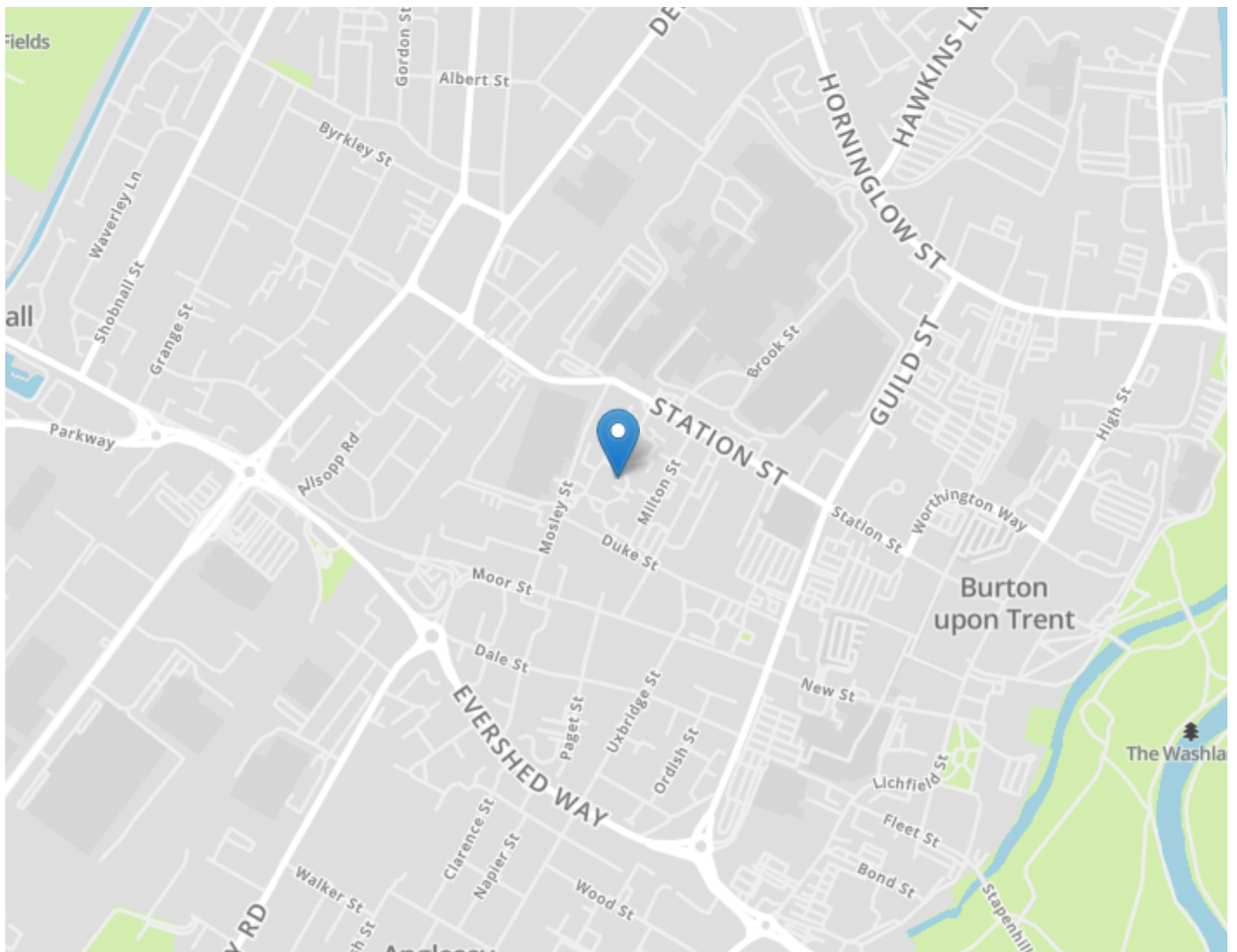


First Floor
