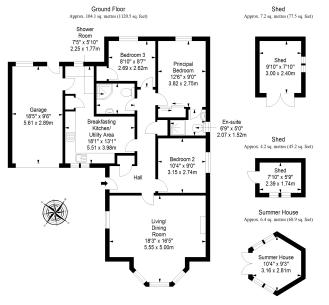






Floorplan
