# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Description</b>	The subjects comprise a two storey semi-detached house.
<b>Accommodation</b>	The accommodation is on two floors and may be summarised as follows:  Ground Floor: Entrance vestibule, hallway, living room, breakfasting kitchen, bathroom (bath, wash basin, wc and shower cubicle).  First Floor: Landing, 3 bedrooms.
<b>Gross internal floor area (m<sup>2</sup>)</b>	100 sq m approx.

<b>Neighbourhood and location</b>	The subjects are located within an established residential area within Darvel built up with a variety of property styles and types and most built originally for the public sector although many are now in private ownership. There are a range of local amenities available within Darvel, Newmilns and Galston all of which are within a short travelling distance of the property under report with further more extensive amenities available within Kilmarnock and Strathaven which are within a commutable distance. There is an established resale market for properties of this type in this location.

<b>Weather</b>	Dry but overcast following several days of mixed weather.

<b>Chimney stacks</b>	<p>The chimney stacks are of brick rendered externally with lead flashings around.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>

<b>Roofing including roof space</b>	<p>The roof over the building is of pitched design and clad with clay tiles and incorporates lead lined valley gutters. There is a flat lead clad section of the roof over the front facing bay windows. A limited inspection of the roof void area was carried out by means of an access hatch in the first floor landing. The presence of stored goods and insulation at ceiling joist level restricted our inspection</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p>

<b>Rainwater fittings</b>	Rainwater fittings are formed in cast iron gutters and downpipes. Visually inspected with the aid of binoculars where appropriate.
<b>Main walls</b>	The main walls appear of brick rendered externally. Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.
<b>Windows, external doors and joinery</b>	The windows are of upvc double glazed type. The front entrance door is of upvc with double glazed panel inserts. The door from the kitchen to the rear elevation is of timber with double glazed panel inserts. Fascias and soffits appear of timber painted externally.  Internal and external doors were opened and closed where keys were available.  Random windows were opened and closed where possible.  Doors and windows were not forced open.
<b>External decorations</b>	Visually inspected.
<b>Conservatories / porches</b>	None.
<b>Communal areas</b>	None.
<b>Garages and permanent outbuildings</b>	None.
<b>Outside areas and boundaries</b>	There are areas of garden to the front, side and rear of the property. The boundaries are defined by a mix of timber fences and hedges. Off street parking is provided within a driveway at the front of the property.  Visually inspected.

<b>Ceilings</b>	<p>Ceilings within the property appear formed in a mix of either lath and plaster and/or plasterboard with decorated finishes.</p> <p>Visually inspected from floor level.</p>

<b>Internal walls</b>	<p>Internal walls appear a mixture of plastered onto masonry and lined construction with a mixture of lath and plaster and/or plasterboard with decorated finishes.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>

<b>Floors including sub floors</b>	<p>The flooring throughout appears of suspended timber with a timber board overlay. Floor surfaces were covered throughout with fitted floor coverings. A limited inspection of the sub floor area was carried out by means of the access hatch in the hall cupboard adjacent to the front entrance door. Due to the depth of the sub floor void and the presence of plumbing and cabling immediately below the access hatch inspection was restricted to an inverted head and shoulders at the access point only. Any areas of the sub floor area which were not visible from the access hatch cannot be commented upon.</p> <p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p>

<b>Internal joinery and kitchen fittings</b>	<p>The property incorporates timber skirting boards and door architraves with timber internal doors. Some internal doors have glazed panel inserts. The kitchen is fitted with a range of floor and wall mounted cabinets.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>

<b>Chimney breasts and fireplaces</b>	<p>There is a fireplace in the living room with an open fire and an electric fire currently used in front of the open fire.</p> <p>Visually inspected. No testing of the flues or fittings was carried out.</p>

<b>Internal decorations</b>	<p>Internal decorations comprise a mix of paper, painted and tiled finishes. There are some artex finishes.</p> <p>Visually inspected.</p>

<b>Electricity</b>	<p>The property appears connected to main supplies of electricity. The electrical switchgear and meters are located within the understair cupboard adjacent to the front entrance door at the ground floor entrance hallway.</p> <p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

<b>Gas</b>	<p>The property appears to mains supplies of gas. The gas meter is located in an external meter box at the rear elevation.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

<b>Water, plumbing, bathroom fittings</b>	<p>The property appears served by mains supplies of cold water. The plumbing where seen is based on copper and pvc materials. The bathroom at ground floor level is fitted with a white bath, wash basin and wc with a shower cubicle. There is a mixer shower at the shower cubicle. The present owner has formed a shower cubicle within the first floor landing cupboard which has been vented to the outside by means of an electrical extractor fan through the ceiling and roof void.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

<b>Heating and hot water</b>	<p>There is a gas fired central heating system installed. The boiler is an Ideal Logic+ Combi C30 boiler. The boiler is located within the ground floor cupboard at the entrance vestibule and flued to the outside wall. Heating is provided by means of steel panelled water filled radiators. Domestic hot water is provided from the central heating system.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>

<b>Drainage</b>	<p>Drainage appears connected to the mains sewerage system.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>

<b>Fire, smoke and burglar alarms</b>	<p>There are smoke and heat detectors.</p> <p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

**Additional limits to inspection**

At the time of inspection the property was unoccupied, however floors were covered with fitted floor coverings. Limited access was gained to the underbuilding area by means of the access hatch in the first floor entrance vestibule cupboard. Inspection was however restricted to the area immediately around the access hatch due to the presence of plumbing and cabling immediately below the uplifted hatch. Therefore the section only immediately adjacent to the hatch by means of an inverted head and shoulders inspection was carried out. The roof void area was inspected, however the inspection was limited to a head and shoulders only at the access point due to the presence of stored goods and insulation material.

External areas of the property have been viewed from ground level only from the garden grounds of the subject property and adjacent public areas. Any areas of the property that were either inaccessible or unexposed cannot be commented upon.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

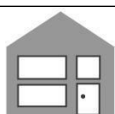

Notes	At the time of our inspection there was no evidence of significant structural movement noted to affect the property within the limits of our inspection.	
	<b>Dampness, rot and infestation</b>	
Repair category	3	
Notes	<p>During the course of inspection evidence of high damp readings were noted to affect the property in a number of areas. There is evidence of damp staining and readings within the front elevation at the half landing of the staircase, within the front facing bedroom around the windows below the valley gutters and in addition there is also evidence of decay in the timbers adjacent to the shower tray within the first floor landing cupboard. In the circumstance we would recommend that the entire property is checked by a competent firm of timber/damp specialists to include the inspection of the sub floor area and roof void and carry out all remedial repairs as required. We have been provided subsequent to our inspection with a report prepared by Rowallan Specialist Surveys dated 2/04/2024, following their inspection and note that they are satisfied there is not rot evident in the roof, and the areas affected by penetrating damp from the walls and roof should be dealt with by a roofing/building contractor. The report estimates the cost of treating the rot at the shower tray at £2450 + VAT. Our valuation is prepared on the assumption of these costs. these works should be carried out in early course and guarantees obtained on completion.</p>	

	<b>Chimney stacks</b>	
Repair category	2	
Notes	<p>The rendering to the chimneys appears cracked and weathered in appearance. The flashings around the chimneys are of older lead. It should be appreciated that the leadwork as it becomes old can often become porous and these sections should be monitored and repairs effect if necessary.</p>	
	<b>Roofing including roof space</b>	
Repair category	2	
Notes	<p>The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan. There is a flat lead clad roof over the front facing bay window. It should be appreciated that flats roofs may become porous with age and damp penetration can result. Flat roofs should therefore be kept under constant review and checked during the course of normal routine roof maintenance.</p> <p>There is evidence of some damp penetration affecting the property at the front facing bedroom window which we suspect is a consequence of defective roofing materials and/or lead flashings/valley gutters. There is evidence of staining within the roof space and whilst this appears old and indicative of the roofs age it should be appreciated that the roof is nearing the end of its lifespan and will require ongoing maintenance in the short to medium term to keep in a watertight state.</p>	
	<b>Rainwater fittings</b>	
Repair category	2	
Notes	<p>The rainwater fittings were noted to be corroded in places. Where corrosion occurs this can result in leakage. It was not raining at the time of inspection.</p>	
	<b>Main walls</b>	

Repair category	2
Notes	The external rendering appears cracked and bossed in places. As indicated above there is evidence of some damp ingress at the half landing at the front elevation and it is likely that repairs will be required to remedy same. We have recommended a timber/damp specialist is initially instructed to investigate the source of damp ingress and upon completion of this report repairs should be carried out as advised. The facing brick was noted to be weathered at the front elevation and there is evidence of some repointing required to mortar joints.



## Windows, external doors and joinery

Notes	<p>These generally appeared in fair condition consistent with age.</p> <p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/ repair will be required as part of an ongoing maintenance programme.</p> <p>Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.</p> <p>We are advised by the present owner that the windows have been replaced during recent years.</p>



Early forms of Artex may incorporate small amounts of asbestos based bonding materials and therefore specialist advice should be obtained prior to working on these areas to minimise the risk of releasing hazardous fibres.</p>	

	<b>Floors including sub-floors</b>

Notes	<p>Flooring appears generally level and firm to the tread. A limited inspection of the sub floor area was carried out by means of the access hatch within the cupboard at the entrance vestibule adjacent to the front entrance door. Where seen there appears to be a reasonable depth of sub floor clearance. Where seen the damp proofing appears intact and the small section around the access hatch was noted to have some underfloor insulation around the access hatch. I was unable to see beyond the area around access hatch therefore cannot confirm if the insulation extends beyond the area below the access hatch. The solum where seen appears stained and may be damp. Due to the depth of underbuilding the solum is likely to be below ground level and may consequently be prone to some residual damp and should therefore be monitored. As indicated above we have recommended a timber/specialist is instructed to inspect the entire property including the sub floor area and any comments/recommendations thereon should be carried out.</p>

Notes	<p>The internal joinery is generally inkeeping with the age and type of property and appeared in fair order consistent with age.</p> <p>The kitchen units are of a modern type and appeared in adequate condition for their age and purpose.</p>

Notes	<p>There is an open fire within the fireplace within the living room. It should be emphasised that flues were not checked or appliances tested.</p>

This will require ongoing and regular servicing.</p> <p>We are advised by the present owner the central heating boiler has been installed in recent times. Notes	<p>The property is thought to be connected to a main sewer. There was no surface evidence to suggest the system is choked or leaking.</p>

Unrestricted parking within 25 metres: For this purpose, ‘Unrestricted parking’ includes parking available by means of a parking permit. Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coin-operated machines.

#### 4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

##### **Matters for a solicitor or licensed conveyancer**

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The roads and footpaths fronting the property appear made up to an adoptable standard and assumed adopted for maintenance purposes by the Local Authority.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the formation of a shower cubicle within the first floor landing cupboard.

##### **Estimated reinstatement cost for insurance purposes**

**£300,000**

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £300,000 (Three Hundred Thousand Pounds Sterling).

##### **Valuation and market comments**

**£110,000**

Market Value assuming vacant possession is £110,000 (One Hundred and Ten Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

## DESCRIPTION OF THE REPORT

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

### 2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

### 2.3.3 Category 1:

No immediate action or repair is needed.

#### WARNING:

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. During the course of inspection evidence of high damp readings were noted to affect the property in a number of areas. There is evidence of damp staining and readings within the front elevation at the half landing of the staircase, within the front facing bedroom around the windows below the valley gutters and in addition there is also evidence of decay in the timbers adjacent to the shower tray within the first floor landing cupboard. In the circumstance we would recommend that the entire property is checked by a competent firm of timber/damp specialists to include the inspection of the sub floor area and roof void and carry out all remedial repairs as required. We have been provided subsequent to our inspection with a report prepared by Rowallan Specialist Surveys dated 2/04/2024, following their inspection and note that they are satisfied there is not rot evident in the roof, and the areas affected by penetrating damp from the walls and roof should be dealt with by a roofing/building contractor. The report estimates the cost of treating the rot at the shower tray at £2450 + VAT. Our valuation is prepared on the assumption of these costs. these works should be carried out in early course and guarantees obtained on completion.

The subjects are located within an established residential area within Darvel built up with a variety of property styles and types and most built originally for the public sector although many are now in private ownership. There are a range of local amenities available within Darvel, Newmilns and Galston all of which are within a short travelling distance of the property under report with further more extensive amenities available within Kilmarnock and Strathaven which are within a commutable distance. There is an established resale market for properties of this type in this location.


The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the formation of a shower cubicle within the first floor landing cupboard.

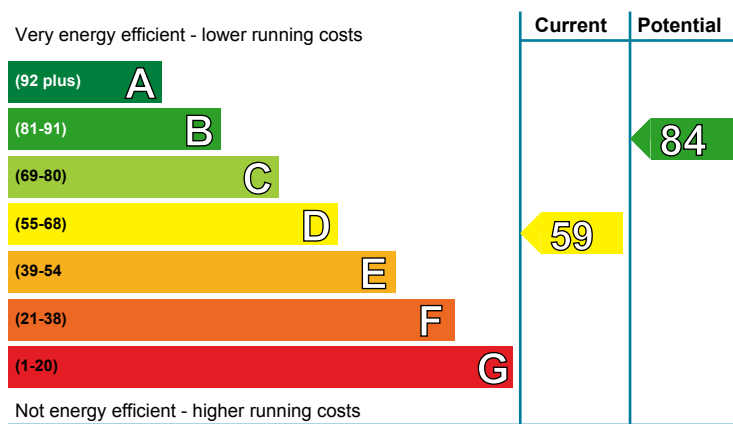

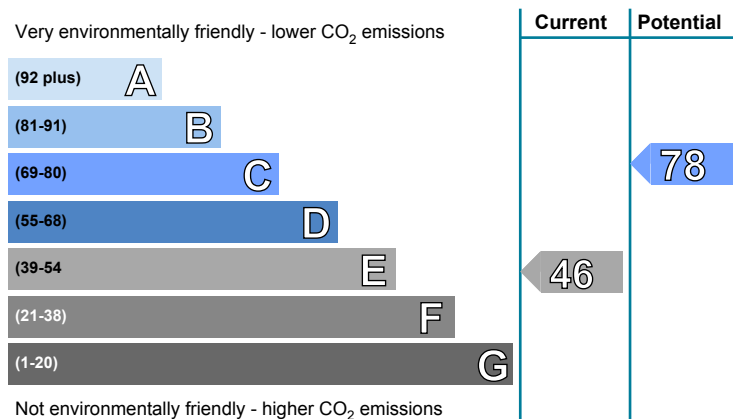

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. The calculated emissions for your home are 67 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. 

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Loft insulation

Loft insulation laid in the loft space or between roof rafters to a depth of at least 270 mm will significantly reduce heat loss through the roof; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulation should not be placed below any cold water storage tank, any such tank should also be insulated on its sides and top, and there should be boarding on battens over the insulation to provide safe access between the loft hatch and the cold water tank. The insulation can be installed by professional contractors but also by a capable DIY enthusiast. Loose granules may be used instead of insulation quilt; this form of loft insulation can be blown into place and can be useful where access is difficult. The loft space must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about loft insulation and details of local contractors can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)).

### 2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

### 3 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 4 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (<http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting>).

### 5 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at [www.microgenerationcertification.org](http://www.microgenerationcertification.org).

### 6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
