Floorplan

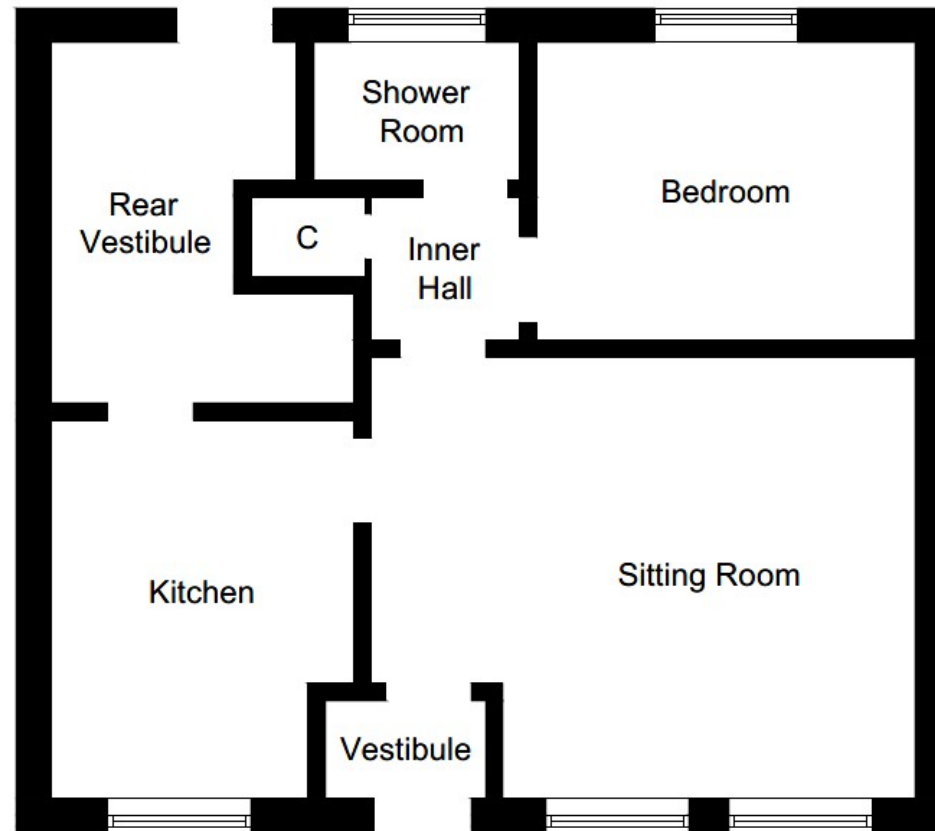
