# Property Description

Tastefully presented and spacious, two-bedroom, modern, midterrace house, with private gardens and a driveway. Located in a quiet cul-de-sac, in an established residential area, just north of Ayr town centre.

Comprises an entrance hall, living room, dining/kitchen, two double bedrooms and a family bathroom.


Highlights include a fitted kitchen and a modern bathroom, contemporary flooring, well-proportioned rooms and a spacious, versatile loft. In addition, there is gas central heating, double-glazed windows and multiple TV points.

Externally, there is a lawn and paved driveway to the front, whilst the rear garden has both turfed and synthetic lawns, a paved patio, and a shed.

A bright entrance hall, finished with light, neutral decor and modern, wood-effect flooring, leads into a living room on the left. This spacious, dual-aspect reception room is flooded with natural light and offers a flexible floorplan for freestanding furniture. Set to the rear, providing garden access, a dining kitchen offers generous space for a dining table and chairs and is fitted with wood-effect units, marble-effect worktops and splashback and floor tiling. A freestanding cooker is included, whilst plumbing and space are available for additional appliances.

Upstairs, set off a naturally lit landing, with storage, two wellproportioned double bedrooms are carpeted for comfort, with one further benefiting from built-in wardrobe storage. A good-sized family bathroom comprises a three-piece suite, a shower-overbath and tiled splash walls.

A floored loft, with power and light, offers an extensive, versatile space.
