# **Property Description**

Well-presented and proportioned, one-bedroom, dual-aspect, corner flat on the fourth floor (top) of a factored and lift-served residential development. Forming part of a characterful converted bond warehouse in Leith's Shore area, to the north of Edinburgh city centre.

Comprises an entrance hallway, a living/dining room, a kitchen, a double bedroom, and a bathroom.

Requiring updating, features include a spacious layout with good room sizes, double glazing, and electric heating. Additionally, there is superb storage, including a partially floored loft space and a designated store in the communal hall.

The development also includes a secure entry system, well-maintained communal halls, and a permit for a private residents' car park to the rear.

The property is entered via a welcoming hallway that provides access to all rooms, with the living room situated at the rear, offering a comfortable space with carpeted flooring and light décor that creates a bright and neutral setting. At the front of the home, the kitchen is fitted with wood-effect countertops, a tiled splashback and a sink with a drainer, as well as space for essential appliances, making it a practical and functional area.


