Light and tastefully presented, two-bedroom, third-floor (top) flat, forming part of a traditional, stone-built tenement.

Located in a desirable crescent, around a central park, in the Dalry area, just west of Edinburgh city centre.

Comprises an entrance hall, an open-plan living/dining room and kitchen, two flexible bedrooms and a bathroom.

Highlights include a fitted kitchen, with integrated appliances and solid wood worktops, a bright bathroom, gas central heating, double glazing and open views across Murieston Park.

In addition, there are tall ceilings and period features, varnished hardwood flooring and good storage, including a flexible hall store.

There is a secure entry system and a well-maintained, secluded, shared garden, with zoned parking to the front and on the surrounding streets.


A spacious entrance hall, with storage, is finished with light, neutral decor and varnished hardwood flooring, which continues throughout most of the flat. A well-proportioned room, with further storage and an original fireplace, spans the entire depth of the flat and offers generous, versatile space for both lounge and dining furniture. A kitchen area is fitted with modern units and solid wood worktops, whilst appliances include an integrated oven, a ceramic hob, a fridge/freezer, a dishwasher and a washing machine.

A high-ceilinged bedroom features smooth cornicing and provides ample floorspace for freestanding furniture and storage, whilst a second bedroom offers a good-sized, flexible space.



Area Description

Dalry is a high-amenity area within walking distance of Haymarket Station, Edinburgh's West End and the city centre.
