Summary

Slightly elevated from the street level this is a newly created east-facing ground-floor apartment accessed via a secure gate of Cowgate, it has a good level of privacy from passing pedestrian footfall. The apartment has been fully developed and offers 2 bedrooms a temporarily designed open living dining and kitchen, and a bathroom with a separate shower cubicle. 


