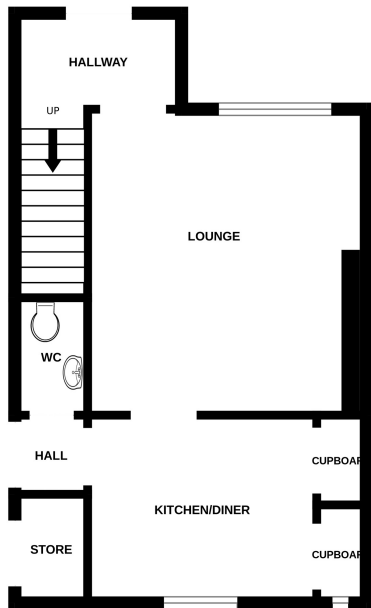

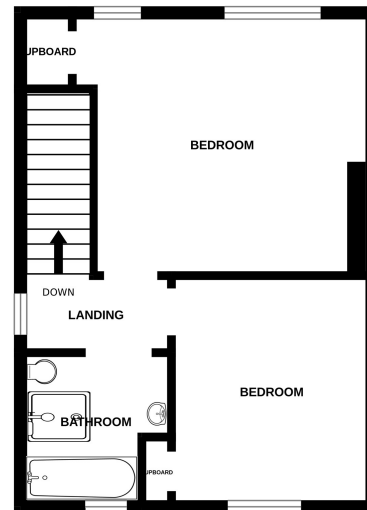


Floorplan
