## Summary

Detached four-bedroom villa with generous scope for refurbishment and redesign. The property offers a well-proportioned layout across two levels. On the ground floor you will find a welcoming lounge, a kitchen, two double bedrooms and a shower room, while two further double bedrooms are arranged upstairs along with a large walk-in cupboard which could be converted into a bathroom. Although the house requires upgrading and modernization, its classic proportions and potential make it an ideal canvas for a new owner. Externally, the villa is complemented by both front and rear garden areas, providing private outdoor space ripe for landscaping. A driveway leads to a single garage, offering secure parking and additional storage. The footprint and external features afford opportunities to reimagine the gardens, extend, or refresh the elevations in line with modern tastes.





