Property Description

Tastefully presented, two-bedroom, traditional upper villa, with gardens, driveway and a detached garage. Located in an established residential area of the village of Ladybank, near Cupar Fife.

Comprises an entrance hall and stairway, a living room, a kitchen, two double bedrooms, and a family bathroom.

Features include a fitted kitchen, recessed spotlighting, modern gas central heating and double glazing, In addition, there is good storage provision including a loft with previous planning for a conversion.

This generous corner plot incorporates the garage with power and lighting, two storage sheds, a patio, a lawn, and a multi-vehicle driveway.

A welcoming entrance, with carpeted stairs leading into the hall, affords access throughout the majority of the property. Set to the front, a spacious lounge includes light neutral decor, wood effect flooring, a feature fireplace, a press with shelves, and twin windows allowing plentiful natural light. Also, set to the front, the kitchen is fitted with wall and base units, stone effect worktops, a tiled surround, and an integrated oven and gas hob.

Bedroom one is set to the rear, offering an exceptionally generous room, tastefully finished with carpeted flooring, a wall-mount TV point, a built-in wardrobe and ample space for further storage. Bedroom two is set off the lounge and offers another good-sized double bedroom. Completing the accommodation, with side aspect windows, the bathroom is fitted with a three-piece suite including an electric shower over the bath and tiled splash walls.



Ladybank is a small village in central Fife, situated between Cupar and Glenrothes, about 62 kilometres north of Edinburgh and 29 kilometres southwest of Dundee, close to the River Eden.
