## A: Property Register

This register describes the land and estate comprised in the title.

WOKINGHAM

- 1 The Freehold land shown edged with red on the plan of the above Title filed at the Registry and being 36 Mercury Avenue, Wokingham (RG41 3GA).
- 2 A Conveyance of the land in this title and other land dated 4 May 1976 made between (1) Calgary and Edmonton Land Company Limited (2) Douglas Archibald Clarke and (3) Wokingham District Council contains the following provision:-  
  
"This Conveyance does not include any easement or right which would or might interfere with or restrict the free use of the adjoining or neighbouring land of the Company at Woosehill for building or any other purposes whatsoever."
- 3 The land has the benefit of the rights granted by but is subject to the rights reserved by the Transfer dated 15 January 1982 referred to in the Charges Register.

NOTE: The rights and other matters in the Property Register of Title BK181936 to which the Transfer refers are (1) rights of way for the Bracken Estate over Mercury Avenue and Heron Road (2) rights for the said Estate to connect with and use the drains and other services over and in land lying to the south and (3) the provision set out in the Note above.

- "THE Company so as to bind the whole of the land transferred to them by this deed and for the benefit of the adjoining land of the Council being the remainder of the land comprised in Title Number BK143454 HEREBY COVENANT with the Council that the Company will at all times hereafter observe and perform the restrictions set out in the third part of the First Schedule

Not to use the land hereby transferred other than for the erection of dwellinghouses for subsequent disposal to owner occupiers."
