Summary

Slightly elevated from the street level this is a newly created south-facing ground-floor apartment accessed via a secure gate of Cowgate, it has a good level of privacy from passing pedestrian footfall. The apartment has been fully developed and offers 2 bedrooms a contemporarily designed open living dining and kitchen, and a bathroom with a separate shower cubicle. The location gives immediate access within walking distance to several local amenities including shops, Gallacher Retail Park, restaurants, public houses, leisure facilities, universities and bus stops. The building's conversion has created apartments that are finished to a high standard with newly fitted kitchens and bathrooms, heating is provided by electric heating backed up by double-glazed period-style sash and case windows. Extras included are kitchen appliances and floor coverings throughout.

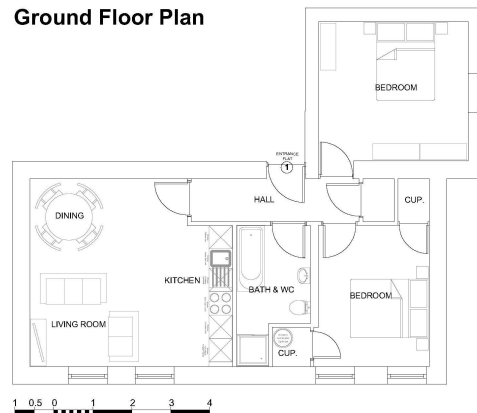
