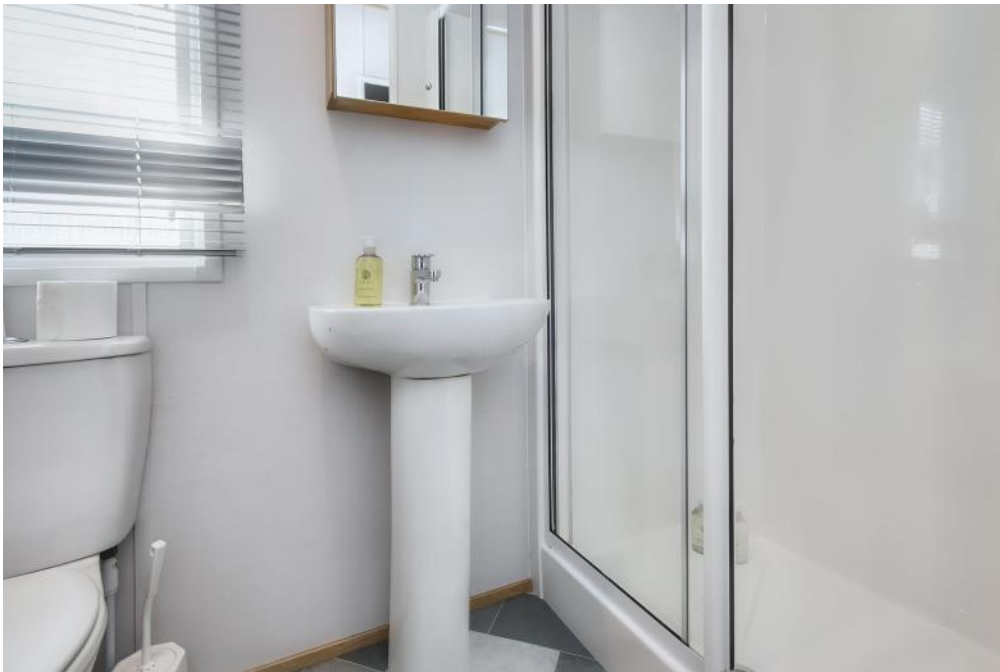
Summary

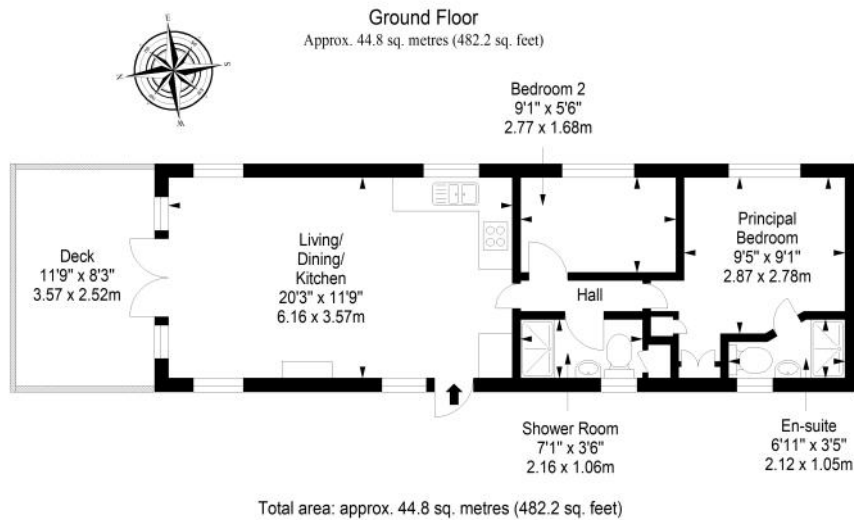
