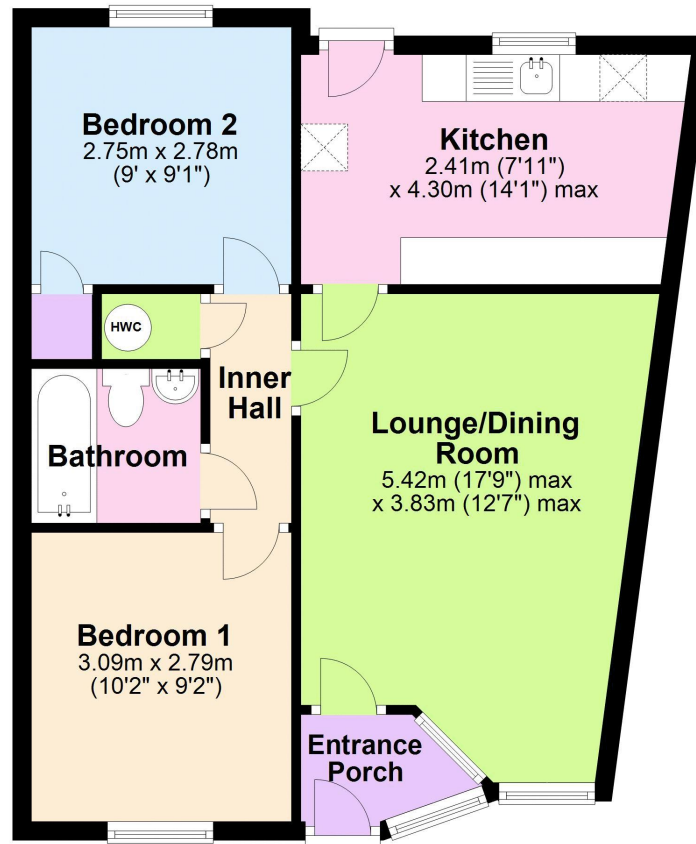
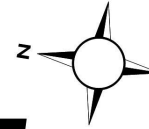
There are well-maintained communal grounds with parking and to the rear there is a pathway with railings beyond which is a stream and a pleasant outlook.
