Bright and spacious, three-bedroom, dual-aspect, first floor flat with a private balcony. Located close to excellent shopping and transport links, in the established Niddrie area, south-east of Edinburgh city centre.


Comprises an; entrance hallway, living room, kitchen, three flexible bedrooms, and a bathroom. With light neutral decor throughout, features include a modern fitted kitchen and bathroom, gas central heating and double glazing.

In addition, there are TV and phone points, and excellent storage provision including an allocated external storage lock-up. There is a shared and enclosed drying yard to the rear featuring access to the storage lock-up, and unrestricted street parking to the front.

The hall gives access throughout, and features a built-in store cupboard and carpeted flooring. Front facing is a good-sized, dual-aspect living room with carpeted flooring and a central pendant light fitting. Also front facing is the kitchen, which has a built-in store and access to the private balcony. Fitted units include stone-effect worktops, modern wall-panelling splashback, sink with drainer, fridge/freezer, washing machine and an integrated oven and gas hob. All three bedrooms have leafy views to the rear, and include carpeted flooring, with bedroom one also featuring a built-in mirrored wardrobe and a built-in store cupboard. A family size bathroom has a front facing window and is fitted with a modern three piece suite including a shower unit over the bath

Niddrie is an established residential area, located east of Edinburgh centre. Local shops can be found throughout, including a Lidl supermarket and an extensive range of high-street names and a multiplex cinema at Fort Kinnaird, an ASDA at the Jewel, with Cameron Toll Shopping Centre offering additional shopping facilities plus a Sainsbury's superstore.
