Floorplan

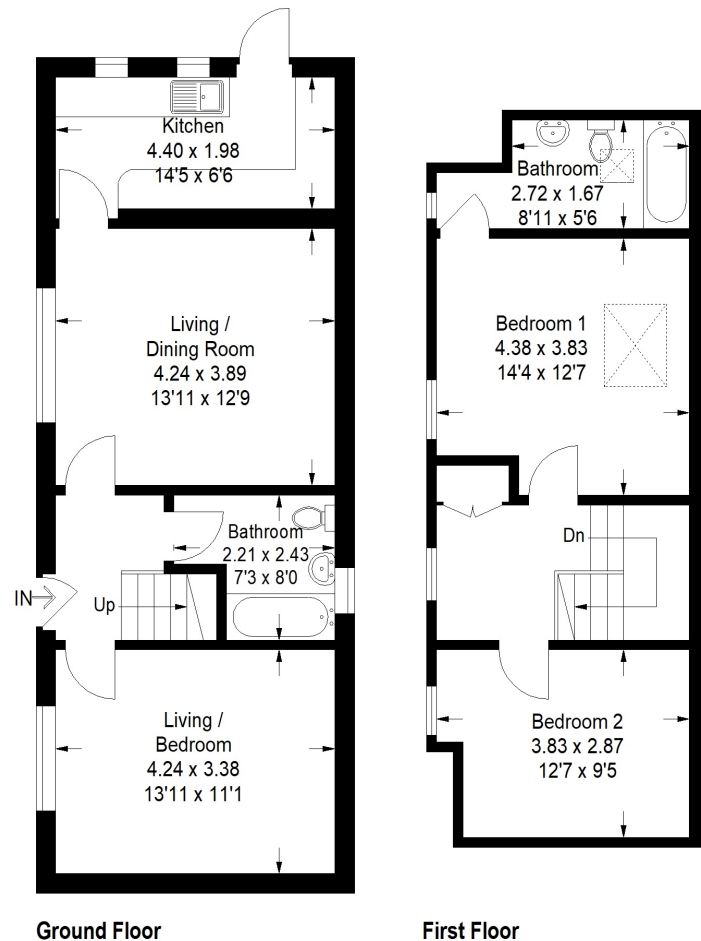
