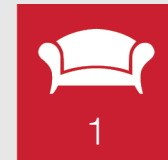




94 Sauchope Links Holiday Park

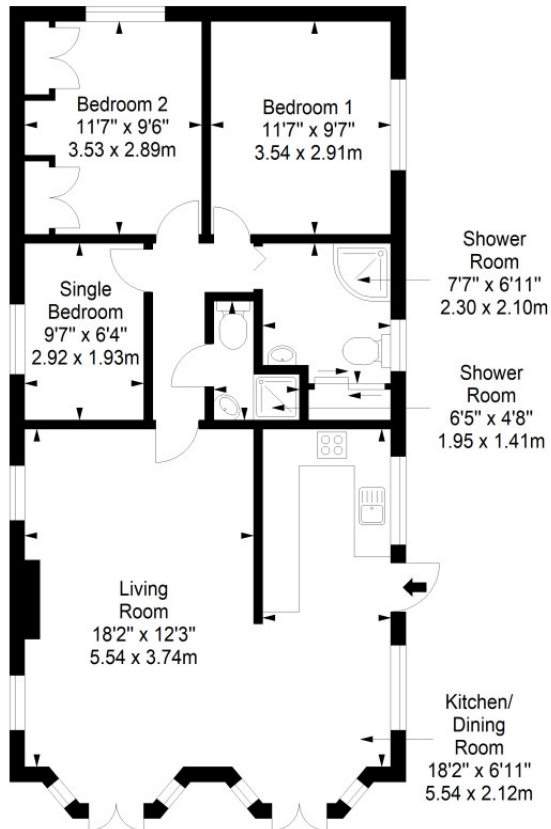
