A: Property Register

This register describes the land and estate comprised in the title.

WOKINGHAM

- 1 The Freehold land shown edged with red on the plan of the above Title filed at the Registry and being 4 Rowland Place, Wokingham (RG41 4BR).
- 2 The Conveyance dated 6 June 1955 referred to in the Charges Register contains the following provision:-

"IT is hereby expressly agreed and declared that the Purchaser and the persons deriving title under him shall not be entitled to any right of light or air or otherwise which would or might in any way prejudicially affect the free and unrestricted user by the Vendor and the persons deriving title under him of any neighbouring or adjoining property of the Vendor for building or other purposes."
- 3 (18.07.2007) The land has the benefit of the rights granted by but is subject to the rights reserved by the Transfer dated 8 June 2007 referred to in the Charges Register.
- 4 (18.07.2007) The Transfer dated 8 June 2007 referred to above contains a provision as to boundary structures.

B: Proprietorship Register

- 2 Two Transfers together comprising the land tinted pink on the title plan and other land both dated 10 March 1999 and made between (1) The Solicitor for the Affairs of Her Majesty's Treasury (Transferor) and (2) Helen Hodgson (Transferee) contain the following identical covenant:-
- "The Transferee hereby covenants with the Transferor that neither the land hereby transferred nor any part thereof shall be used other than as garden land appurtenant to 128 Evendons Lane aforesaid"
- 3 (22.07.1999) A Transfer of the land tinted blue on the title plan and other land dated 10 March 1999 made between (1) The Solicitor for the Affairs of Her Majesty's Treasury (Transferor) and (2) Fiona Jane Sheila Stears and Damon Carl Treweeke (Transferees) contains the following covenants:-
- "The Transferees hereby jointly and severally covenant with the Transferor that neither the land hereby transferred nor any part thereof shall be used other than as garden land appurtenant to 130 Evendon's Lane aforesaid."
- 4 (18.07.2006) A Transfer of the land tinted pink on the title plan dated 4 April 2006 made between (1) Helen Hodgson (Transferor) and (2) Try Homes Limited (Transferee) contains the following covenants:-
- "The Transferee hereby covenants with the Transferor:-

- (ii) Not to erect any building to be used as flats on the land transferred."
- 5 (18.07.2006) A Transfer of the land tinted blue on the title plan dated 4 April 2006 made between (1) Delphine Gisele Galland and Michael Reginald John Potter (Transferor) and (2) Try Homes Limited (Transferee) contains covenants identical with those contained in the Transfer of the land tinted pink on the title plan dated 4 April 2006 referred to above.
- 6 (18.07.2006) A Transfer of the land tinted mauve on the title plan dated 4 May 2006 made between (1) Terry Clooney and Angela Constance Clooney (Transferor) and (2) Try Homes Limited (Transferor) contains the following covenants:-

"The Transferee hereby covenants with the Transferor:-

(ii) Not to erect any building more than two storeys in height on the land transferred."

- 7 (06.11.2006) An Agreement dated 1 February 2006 made between (1) The Treasury Solicitor and (2) Perfectfield limited as varied by a Deed dated 22 February 2006 made between the same parties relates to two Option Agreements affecting the land tinted blue and tinted pink on the filed plan as therein mentioned.

- 8 (23.01.2007) By a Deed dated 21 December 2006 made between (1) The Solicitors for the Affairs of Her Majesty's Treasurer and (2) Try Homes Limited the covenants contained in the Deed dated 10 March 1999 referred to above were expressed to be released.
