# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Description</b>	The subjects comprise a two storey detached house.
<b>Accommodation</b>	Ground Floor: Conservatory, hallway, living room, family room, open plan dining kitchen, bedroom 1, toilet. First Floor: Landing, 4 bedrooms and bathroom.
<b>Gross internal floor area (m<sup>2</sup>)</b>	214 approx.
<b>Neighbourhood and location</b>	The subjects are located in a semi-rural location a short distance from the village of Crosshill. Limited local amenities are available within Crosshill with further more extensive amenities being available within Maybole and Ayr which are within a commutable distance.
<b>Age (year built)</b>	Circa 1986

<b>Weather</b>	Dry but overcast following several days of unsettled weather.

<b>Chimney stacks</b>	N/A

<b>Roofing including roof space</b>	<p>The roof is of pitched design and clad with synthetic slates, with lead lined valley gutters. A limited inspection of the roof void areas were carried out by means of the access hatches in the first floor. Inspection was restricted to the access from the cupboard off the first floor main bedroom and to the apex void. The roof void area is insulated at ceiling joist level, around the room in the roof and at the apex void.</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p>

<b>Rainwater fittings</b>	<p>Rainwater fittings are formed in UPVC gutters and downpipes.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>

<b>Main walls</b>	<p>The outer walls appear of timber frame construction with a brick or block outerleaf rendered externally.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p> <p>Foundations and concealed parts were not exposed or inspected.</p>

<b>Windows, external doors and joinery</b>	<p>The windows are of UPVC double glazed type. The external doors are a mixture of UPVC and timber with double glazed panel inserts. Fascias around soffits and eaves are a mixture of UPVC and timber.</p> <p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p>
<b>External decorations</b>	Visually inspected.
<b>Conservatories / porches</b>	<p>There is a conservatory at the front of the house which forms an entrance vestibule which appears of brick to sill level with UPVC windows and doors and a polycarbonate roof over. There are double glazed UPVC doors to the outside from the conservatory.</p> <p>Visually inspected.</p>
<b>Communal areas</b>	N/A
<b>Garages and permanent outbuildings</b>	<p>There is a large concrete block and steel framed and clad outbuilding within the garden grounds which has been sub-divided to form several sections including garage, storage and stables.</p> <p>Visually inspected.</p>
<b>Outside areas and boundaries</b>	<p>The property is set within immediate gardens with a field/paddock to the rear. We are advised the site extends to approximately 3 acres or thereby. There is a large hardstanding/parking area to the right hand side of the house. Boundaries are formed in a mix of brick walls, post and wire fences, hedging and bounded at one side by a small burn.</p> <p>Visually inspected.</p>

<b>Ceilings</b>	<p>Ceilings appear formed in plasterboard or similar with decorated finishes.</p> <p>Visually inspected from floor level.</p>
<b>Internal walls</b>	<p>Internal partitions appear of timber stud or similar lined on both faces with plasterboard. Inside faces of outer walls are lined throughout with plasterboard. There are a mixture of papered and tiled finishes.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>
<b>Floors including sub floors</b>	<p>Flooring throughout appears of suspended timber with a timber board overlay. Floor surfaces were covered throughout with fitted floor coverings. No access was gained to any underbuilding area.</p> <p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p>
<b>Internal joinery and kitchen fittings</b>	<p>The property incorporates timber skirting boards and door architraves with timber internal doors. The kitchen is fitted with a range of floor and wall mounted cabinets.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>

<b>Chimney breasts and fireplaces</b>	<p>There is a solid fuel fire within the hallway which is flued to roof level by means of a metal flue through the property and through the roof to outside.</p> <p>Visually inspected. No testing of the flues or fittings was carried out.</p>
<b>Internal decorations</b>	<p>Internal decorations comprise a mix of papered, painted and tiled finishes.</p> <p>Visually inspected.</p>
<b>Cellars</b>	N/A
<b>Electricity</b>	<p>The property appears connected to mains supplies of electricity. The electrical switch gear is located within the front facing living room with the meter located within an external meter box.</p> <p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>
<b>Gas</b>	<p>The property is connected to liquid propane gas (LPG). The propane tank is located within the garden grounds.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

<p><b>Water, plumbing, bathroom fittings</b></p>	<p>We are advised the property is connected to a private water supply. The plumbing where seen is based on copper and PVC materials. The cloakroom has a white wash basin and wc. The bathroom has a white freestanding bath, wash basin, wc and shower cubicle with mixer shower.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

<p><b>Heating and hot water</b></p>	<p>There is an LPG fired central heating system installed. The boiler is an Ideal Mexico Super 2 (RS 75P) system boiler which is located within the cupboard off the master bedroom. Heating is provided by means of steel panelled water filled radiators. Domestic hot water is provided from the central heating system. There is a hot water storage tank located within the cupboard adjacent to the boiler.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>

<p><b>Drainage</b></p>	<p>Drainage is understood to be connected to a septic tank which is located within the garden adjacent to the agricultural shed.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>

<b>Fire, smoke and burglar alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

<b>Additional limits to inspection</b>	<p>At the time of inspection the property was occupied, furnished and floors covered throughout with fitted floor coverings. No access was gained to the underbuilding area. The roof void area was inspected however only limited sections of the roof were visible and where seen were restricted by the presence of insulation material.</p> <p>External areas of the property have been viewed from ground level only from the garden grounds of the subject property and adjacent public areas. Any areas of the property which were either inaccessible or unexposed cannot be commented upon.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>



Notes	At the time of our inspection there was no evidence of significant structural movement noted to affect the property within the limits of our inspection.

Notes	There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection.	
	<b>Chimney stacks</b>	
Repair category	1	
Notes	There are no chimney stacks however the metal flues from the boiler and the solid fuel fire appeared to exit the roof at roof level and appeared in fair order.	
	<b>Roofing including roof space</b>	
Repair category	2	

Notes	The roof cladding is of original synthetic slates with lead lined valley gutters. Evidence of moss growth on the slates in places and also evidence of vegetation and moss in the gutter. Whilst there is no evidence of damp staining internally we would caution that as the roof fabric becomes older regular ongoing maintenance will be required to keep the roof in a wind and watertight condition.
	<b>Rainwater fittings</b>
Repair category	1
Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.
	<b>Main walls</b>
Repair category	1
Notes	The main outer walls of the property generally appeared in fair order consistent with age.
	<b>Windows, external doors and joinery</b>
Repair category	2
Notes	<p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/ repair will be required as part of an ongoing maintenance programme.</p> <p>There is evidence of condensation affecting a number of the double glazed sealed units. These will require repair or replacement. The windows appear of mixed age and quality.</p>
	<b>External decorations</b>

Notes	Overhaul/repair works are required to external decorative finishes particularly at eaves etc including possible repairs to external joinerywork prior to redecoration.
	<b>Conservatories / porches</b>
Repair category	2
Notes	There is evidence of condensation between one of the double glazed units within the conservatory and some cracking noted to the external rendering.  The conservatory is of lightweight construction and regular maintenance should be anticipated.
	<b>Communal areas</b>

	<b>Garages and permanent outbuildings</b>
Repair category	2
Notes	The outbuildings structure will require ongoing maintenance and repairs including the roof.
	<b>Outside areas and boundaries</b>

Notes	Outside areas will require ongoing repairs and maintenance. You should verify with your conveyancer the extent of the boundaries attaching to the property.  Boundary fences, walls and hedges will require ongoing maintenance.  The surface of the car parking area was noted to be deteriorating in places and will require ongoing repairs.

Notes	<p>The kitchen has recently been refitted with modern units and the kitchen has been relocated.</p> <p>The internal joinery is generally in keeping with the age and type of property and appeared in fair condition consistent with age.</p> <p>Some internal doors require to be refitted and some redecoration work is required to internal joinery. We are advised by the present owner these works will be completed at their expense prior to the completion of any sale.</p>

Unrestricted parking within 25 metres: For this purpose, ‘Unrestricted parking’ includes parking available by means of a parking permit. Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coin-operated machines.

#### 4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

##### **Matters for a solicitor or licensed conveyancer**

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include alterations to the internal layout to form the present accommodation including relocation of the kitchen, the removal of a number of internal partitions to form the present layout and the construction of a conservatory at the front elevation. We are advised by the present owner the internal alterations carried out during their period of occupancy over the last year were apparently to non-load bearing walls and therefore advised that they did not require consents.

There is a private water supply serving the property. It is assumed that the flow has been continuous for at least 10 years and the water is fit for human consumption. It would be prudent to carry out checks.

Drainage, we understand is to a exclusive septic tank which we understand lies within the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

##### **Estimated reinstatement cost for insurance purposes**

£600,000

The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). Building costs are currently increasing significantly above inflation due to increased demand and supply issues as a result of Brexit and the pandemic. It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover.

We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £600,000 (Six Hundred Thousand Pounds Sterling).

## Valuation and market comments

**£475,000**

Market Value assuming vacant possession is **£475,000** (Four Hundred and Seventy Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box.  Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

\* Which shall be in accordance with the current RICS Appraisal and Valuation Standards (The Red Book) and RICS Rules of Conduct.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

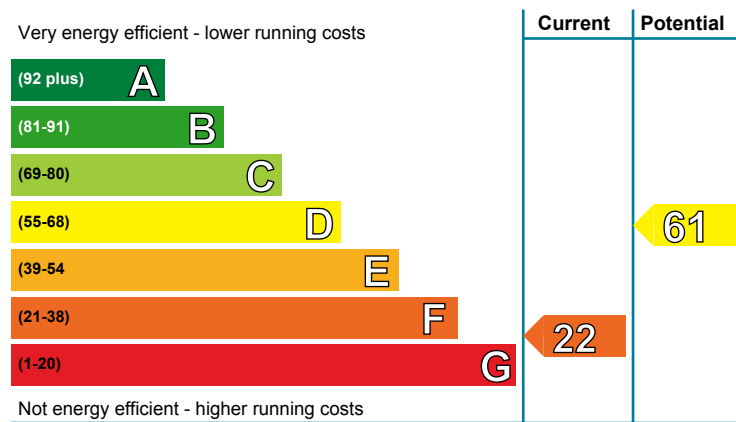

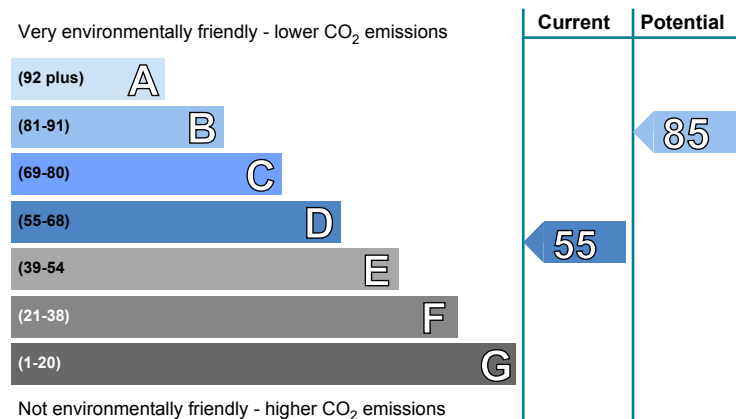

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. ## The impact of your home on the environment

### 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

### 3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### 5 Wind turbine
