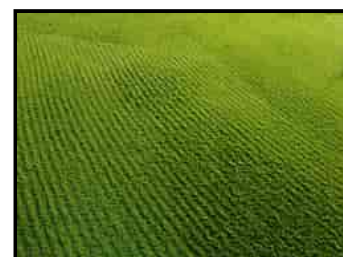

The plot is situated fronting onto the country road which is a dead end. There is a small stream running through the plot. 21 metres approx.

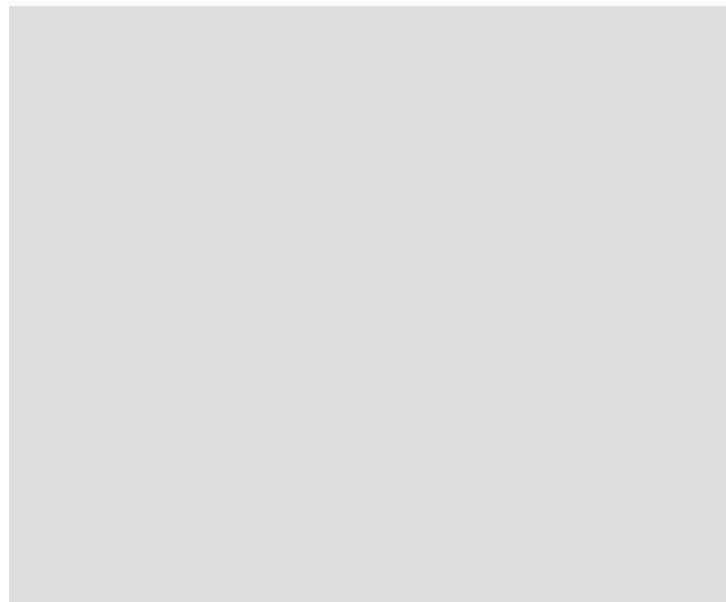
