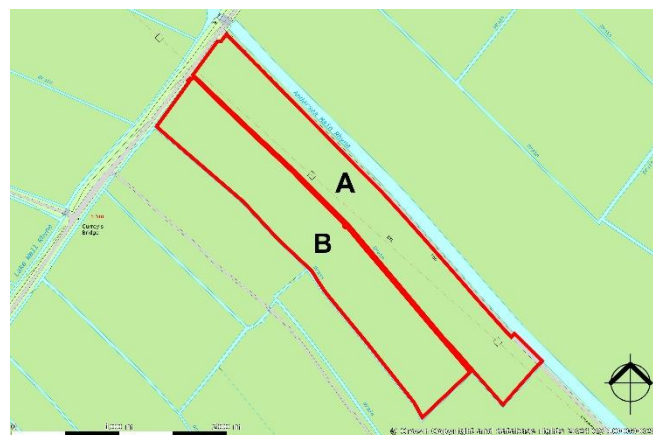

Description

Two extremely attractive parcels of pastureland extending to 9.85 acres (3.99 hectares), located within a secluded position and surrounded by idyllic countryside. Topography is level to each lot, with access taken directly from the Council maintained highway known as Lakewall. Ideally suited for anyone with agricultural or amenity interest, subject to any necessary planning consents required. The soil comprises a loam and clayey type classified as Grade 3 on the DEFRA Land classification map.

Lot A – Guide: £35,000 to £50,000

Single enclosure of pastureland extending to approximately 4.84 acres (1.96 hectares).

Lot B – Guide: £35,000 to £50,000

Single enclosure of pastureland extending to approximately 5.01 acres (2.03 hectares).

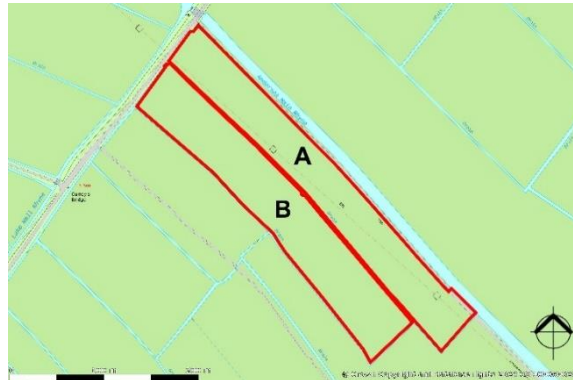
