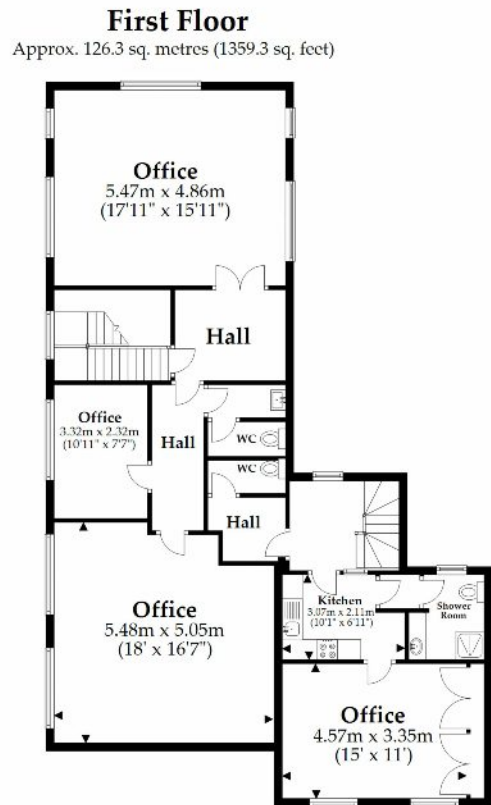
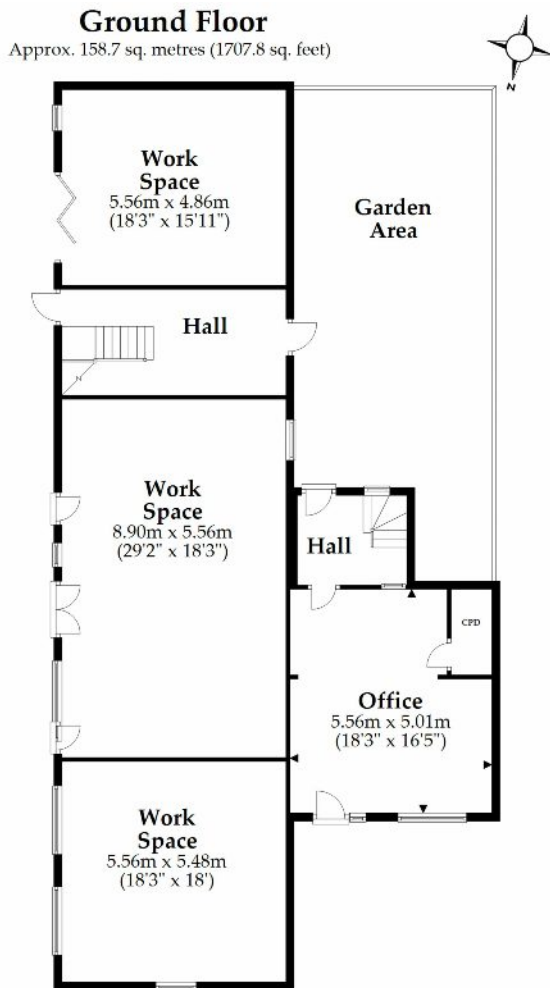

The Situation

Located within a level walk of the town centre of Wimborne along a one way road with easy access onto the nearby Poole Road and A31. The town of Wimborne has medieval origins and over the years has grown into a centre of great style and culture. There are superb facilities here with quality shops, café's and restaurants surrounding the well known square. The local schools, both junior and senior, have good Ofsted ratings and there is a large sports recreation centre just outside Wimborne at Queen Elisabeth school. Good access to Poole and Bournemouth and heading West along the A31 gives a direct route to Ringwood and onwards to Southampton (via M27).

Directional Note

As you head West along the Wimborne bypass (A31) turn left at the Merley roundabout and then take the next left, signposted Wimborne. Continue along this main road over the A31, through the traffic lights and over the bridge. Take your second right into New Borough Road and you will come to the property on your right, signified with an all enquiries board.
