Summary

This traditional cottage is nestled in beautiful unspoilt countryside, just four miles from the twin burgh of Blairgowrie and Rattray, and less than an hour's drive from Perth and Dundee. The surprisingly spacious home is set over two levels and features four bedrooms, two bathrooms, and generous living space. It retains original features paired with sympathetically classic fittings and mainly neutral décor, which is easily adaptable. The charming property occupies a large secluded plot with an enchanting south-facing 1.2 acre garden featuring a summer house. Additionally, there is a garage, long driveway for ample private parking and a 1.75 acre nature/wildlife garden across the road which is also part of the property. 
