# Floorplan

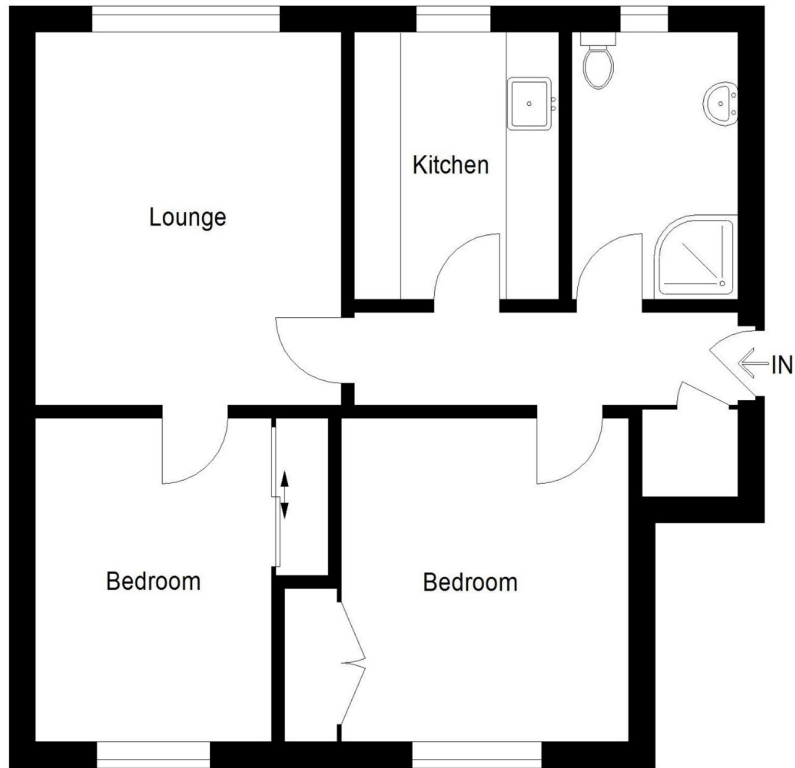
