Location

The development occupies an idyllic position in the village of Cleator on the west coast, a short walk to amenities and just a short drive to major local employment centres. Cleator is located approximately 3 miles from both Whitehaven and Egremont town centres, both of which offer a good range of local amenities, including shops, cafes and well regarded primary and secondary schools.

Property Description

An exciting opportunity to acquire a fully serviced building plot in the desirable village of Cleator, on the outskirts of the western Lake District, commanding open views and a most convenient location close to towns, excellent schools and employment centres.

Plot 7 is the largest of the remaining plots, extending to approximately 754 sqm with outline planning permission for a detached four bedroom house. Outline planning permission was granted on the site in November 2019 for erection of 5 detached dwellings, and once completed this will be an exclusive development of just 7 detached properties.

The plot is fully serviced meaning a purchaser can get to work designing their build straight away. With all mains services and infrastructure in place, including gas, water, BT and electricity. The roads are entered under section 228 for road adoption by the local authority highways, and section 104 for drainage with United Utilities.
