### Wooden front entrance door opening into the

### Open plan Living Space

Kitchen area fitted with wooden wall and base units and wood-effect worksurface, 1½ bowl sink and drainer unit, free-standing electric cooker, space for free-standing fridge/freezer and space and plumbing for washing machine, single glazed window to the front aspect overlooking the front garden. Living area with wooden flooring throughout, useful understairs cupboard, radiator, stairs leading to the first floor, single glazed window to the rear overlooking the communal gardens.

Fitted carpet, radiator, 2 windows, built-in storage cupboard over the stairs and double built-in wardrobes.

#### Bedroom 2

Fitted carpet, radiator, window to the front aspect.

### **Bathroom**

Suite comprising low flush WC, wash hand-basin with storage under, corner shower unit with rainfall showerhead, heated towel rail, recessed spotlighting, window to the front aspect and wooden flooring.

#### Outside

The property is approached via a wooden gate leading onto the garden area with stone path leading down to the front entrance. There is a range of established trees, shrubs and flowers and an area of lawn with a small patio area - perfect for entertaining. To the front there is the oil boiler, tank and useful outside tap. The communal gardens offer additional entertaining space and there is a designated communal stone barn drying room with washing line and space for refuse bins. Separate GARAGE with electric upand-over door, storage space, recessed spotlighting and door into the converted OFFICE/UTILITY with electric and cold water supply,

electric fuseboard, worksurface with space for washing machine and tumble dryer, recessed spotlighting, single glazed door and window to the rear. Useful outside tap. Off-road parking to the front.






