Front door, with inset obscure double glazed panel, leads to:

RECEPTION HALL

Radiator. Electric consumer unit. Smoke alarm. Cloak hanging space. Stairs rising to:

FIRST FLOOR LANDING

Radiator. Access to roof space. Thermostat control panel. Double glazed Velux style window to part pitched ceiling.

Door to:

LOUNGE/DINING ROOM

19'6" (5.94m) x 11'0" (3.35m). A spacious room. Two radiators. Television aerial point. Telephone point. uPVC double glazed window to rear aspect. uPVC double glazed double opening doors, with Juliet balcony, to front aspect.

From first floor landing, door to:

KITCHEN

10'0" (3.05m) x 9'10" (3.0m) maximum. Fitted with a range of matching base, drawer and eye level cupboards. Granite effect roll edge work surfaces with tiled splashbacks. Single drainer sink unit with mixer tap. Fitted oven. Four ring gas hob with filter/extractor hood over. Plumbing and space for washing machine. Plumbing and space for dishwasher. Space for upright fridge freezer. Deep storage cupboard also housing boiler serving central heating and hot water supply. uPVC double glazed window to front aspect.

From first floor landing, door to:

BEDROOM 1

14'10" (4.52m) x 9'10" (3.0m). Radiator. uPVC double glazed window to front aspect.

From first floor landing, door to:

BEDROOM 2

11'4" (3.45m) x 9'4" (2.84m). Radiator. Double glazed Velux style window to part pitched ceiling.

From first floor landing, door to:

BATHROOM

6'8" (2.03m) x 5'6" (1.68m). A matching white suite comprising panelled bath with fitted mains shower unit, glass shower screen and tiled splashback. Wash hand basin with tiled splashback. Low level WC. Radiator. Shaver point. Extractor fan. Double glazed Velux style window to part pitched ceiling.

OUTSIDE

Beneath the property (left hand side) is a:

PRIVATE GARAGE

19'6" (5.94m) x 10'6" (3.20m). Power and light. Up and over door providing vehicle access. Deep understair storage cupboard.


