If you think your band is wrong

Every domestic property is allocated a valuation band. The Valuation Office Agency is responsible for placing properties into their appropriate band.

The valuation bands are based on the amount a property would have sold for on 1 April 1991.

You can appeal to the Valuation office agency if you believe your band is wrong. You must keep paying council tax while your appeal is considered.
