The modern kitchen is finished with wood-effect countertops, a tiled splashback, a sink with drainer, an integrated oven and a gas hob with canopy above, as well as a washing machine and fridge/freezer.

There's ample space for a dining set and a storage cupboard. Both double bedrooms boast wood-effect flooring and light décor, with bedroom one enhanced by ornate comice-work and bedroom two benefiting from double windows, allowing natural light to fill the space. Completing the property is a fully tiled bathroom with paneling, a threepiece suite including a shower over the bath, and a ladderstyle radiator.
