Property Description

Bright and spacious, four-bedroom, duplex flat with private balconies, on the ground and first floor, set quietly within a purpose-built apartment complex, located in the sought-after Bellevue area.


Comprises an entrance hall, living room, kitchen, an upper hall, four double bedrooms, a family bathroom and a first floor WC.

Features include gas central heating, uPVC double glazing, TV and telephone points, and good integrated storage provision. Further features include well kept shared courtyards and permit parking to the front and rear.

The entrance hall has the stairs leading to the upper floor and laminate flooring extending through to the rear facing living room which features a storage cupboard and a southerly facing private balcony. Whilst set off the living room, also featuring a balcony, bedroom four may be used flexibly as a dining or family room. Set to the front, the kitchen features contemporary units, stone effect worktops, a stainless-steel sink with drainer and a gas cooker.

Upstairs on the first floor, there are three generously sized double bedrooms, each with ample space for freestanding bedroom furniture, with bedroom one also enjoying a small private balcony and bedroom two and three featuring built-in storage space. Completing the accommodation, the fully tiled family bathroom features a white three-piece suite including an electric shower over the bath, whilst also including a separate WC adjoining.
