Toughened glass canopy entrance. Composite front door, with inset obscure double glazed panel, leads to:

RECEPTION HALL

Radiator. Electric consumer unit. Stairs rising to first floor. Cloak hanging space. Smoke alarm. Door to:

KITCHEN/BREAKFAST ROOM

10'0" (3.05m) x 9'0" (2.74m) excluding understair recess. A modern kitchen fitted with a range of matching base, drawer and eye level cupboards. Wood effect roll edge work surfaces incorporating breakfast bar. Fitted oven. Four ring electric hob with filter/extractor hood over. 1½ bowl sink unit with single drainer and mixer tap. Plumbing and space for washing machine. Space for upright fridge freezer. Wall mounted concealed heat exchanger. uPVC double glazed window to front aspect. Open plan to:

12'0" (3.66m) maximum x 7'8" (2.30m). Radiator. Two uPVC double glazed windows to front aspect.

From first floor landing, door to:

BATHROOM

6'0" (1.83m) x 5'8" (1.73m). A modern matching white suite comprising panelled bath with modern style mixer tap including shower attachment and tiled splashback. Low level WC. Wash hand basin with modern style mixer tap and tiled splashback. Radiator. Extractor fan.

OUTSIDE

On facing the property the parking spaces are situated either side of a small strip of garden. Access to front door. The rear garden consists of a paved patio with external power point. Small retaining wall with shaped area of lawn. Side pathway leads to the lower end of the garden with timber shed. A rear gate provides pedestrian access. The rear garden is enclosed to all sides.


