Well-presented and spacious, three-bedroom, detached home with gardens, driveway and garage. Located within a quiet culde-sac setting, in an established residential area in Livingston, West Lothian.


Comprises an entrance hall, living room, dining/kitchen, three flexible bedrooms, an en-suite shower room, a family bathroom, and a ground floor WC.


Highlights include a stylish fitted kitchen with integrated appliances, a contemporary four-piece bathroom, and modern flooring. In addition, there is gas central heating, double glazing and good storage provision throughout.

Externally, the property benefits from a driveway and a gravelled patio to the front; whilst the rear garden features a lawn, and gravelled and paved patios.

A welcoming entrance hall affords access to the stairs leading to the upper hall, a convenient ground-floor WC, and a spacious public room. With a dual aspect, allowing plentiful natural light, the living room is finished with light decor, wood effect flooring, coving, two light fittings, a built-in cupboard, a wall-mount TV point, and patio doors leading to the garden, whilst also offering space for dining. Set off, to the rear, a stylish kitchen has further garden access and space for dining, while modern fitted units include stone effect worktops, a tiled surround, a sink with a spray pull-tap; and an integrated gas hob, microwave and oven.

On the upper floor, set to opposite aspects, two well-finished bedrooms are similarly generously sized, both with modern flooring and built-in wardrobes with mirror sliding doors; whilst the master bedroom also features an en-suite shower room. A further double bedroom is set to the front, with wood effect flooring, light decor and a built-in cupboard. Completing the accommodation, the family-size bathroom is fitted with a four-piece suite including a separate shower cubicle and a jacuzzi-style bathtub.
