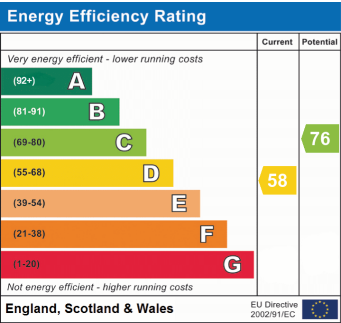
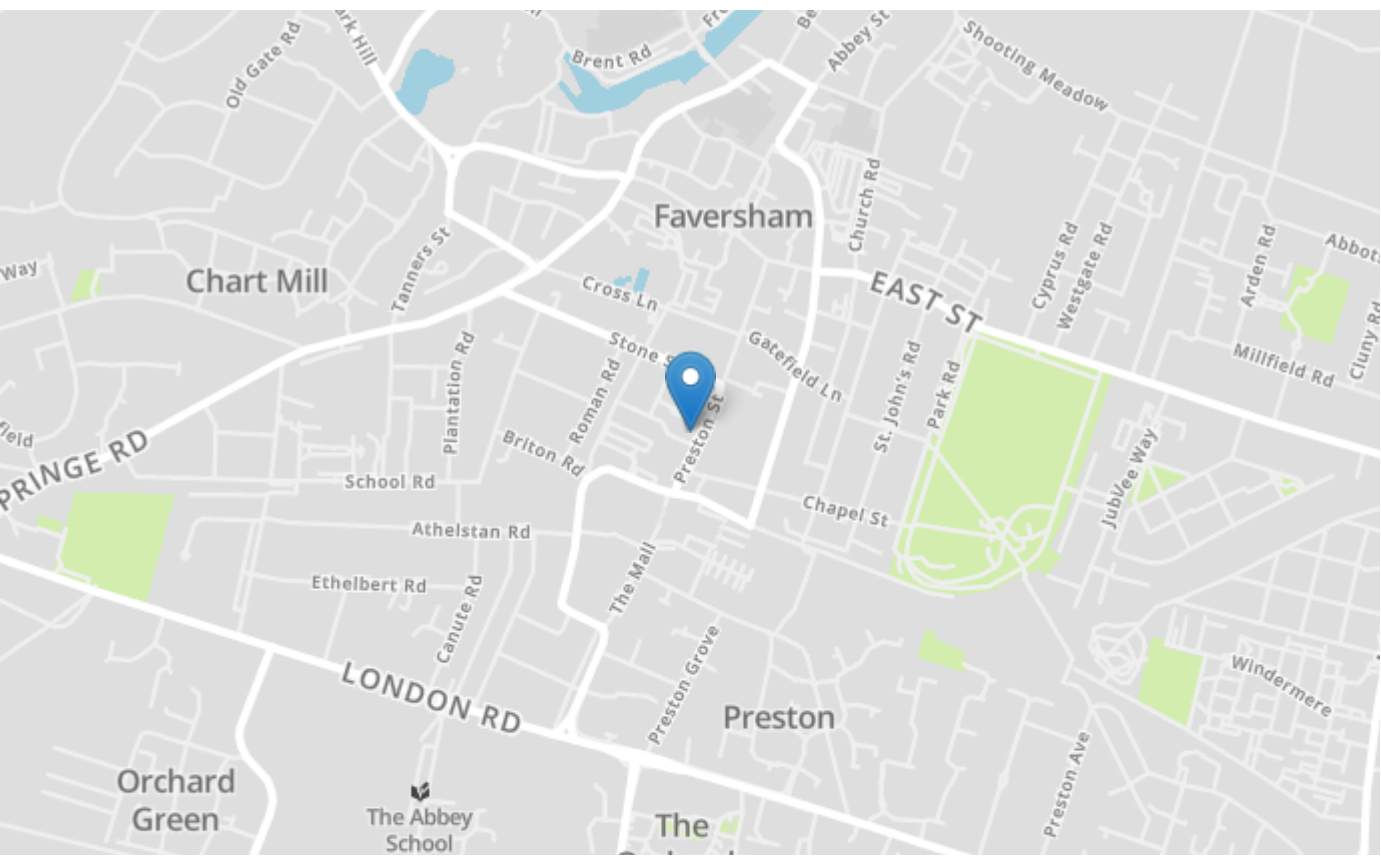
Local Area

Faversham is a market town in Kent, England, 8 miles (13 km) from Sittingbourne, 48 miles (77 km) from London and 10 miles (16 km) from Canterbury, next to the Swale, a strip of sea separating mainland Kent from the Isle of Sheppey in the Thames Estuary. Faversham has a number of landmarks, with several historic churches including St Mary of Charity, Faversham Parish Church, the Maison Dieu and Faversham Recreation Ground. Faversham Market has been established for over 900 years and is still based in the town centre. There are good road and rail links, including a South eastern service to the High Speed 1 line at Ebbsfleet International and London.
