A: Property Register

- 3 The Transfer dated 23 February 1981 referred to above contains a provision as to boundary structures.

- 2 A Transfer of the land in this title dated 23 February 1981 made between (1) Focus Homes Limited and (2) Paul Roderick Davidson contains restrictive covenants.

Schedule of restrictive covenants

- 1 The following are details of the covenants contained in the Transfer dated 22 June 1978 referred to in the Charges Register:-

"8.1 In pursuance of Section 52 of the Town and Country Planning Act 1971 Section 126 of the Housing Act 1974 Section 16 of the Berkshire County Council Act 1953 and Section 6 of the Berkshire County Council Act 1971 the Purchaser covenants that:-

8.1.1 the transferred land or any part or parts thereof will be developed in accordance with the document "Woosehill District Plan" published by Wokingham District Council and in accordance with any Planning Permission for residential development on the transferred land

8.1.2. the transferred land or any part or parts thereof will be used for no purpose other than the erection of dwellinghouses for sale with any usual ancillary outbuildings (and the subsequent use of the houses and outbuildings as private dwellinghouses and outbuildings) and no part of the transferred land shall be disposed of other than a freehold disposal to a person occupying or intending to occupy a dwellinghouse built thereon provided that this covenant shall not prevent the erection and use of any electricity substation or gas governor station or a transfer thereof to the appropriate undertaker

8.1.3 as soon as practicable after the completion of the erection of any dwellinghouse on the transferred land or prior to the erection of such dwellinghouse the freehold interest in the land comprising that dwellinghouse or proposed dwellinghouse shall be conveyed to a person occupying or intending to occupy that dwellinghouse

8.2. The provisions of Clause 8.1, 8.1.1, 8.1.2 and 8.1.3 aforesaid shall be binding upon the Purchaser's successors in title."
