GROUND FLOOR

Hallway

uPVC door with window to the side leading into hallway. Doors leading into lounge, kitchen and carpeted stairs leading to the first floor level. Electric wall heater, ceiling light and power.

uPVC window to the front. Carpeted flooring, wall mounted electric heater, ceiling light and power.

Dining Room

2.5m x 2.7m (8' 2" x 8' 10")

uPVC window to the rear. Serving hatch into kitchen. Space for dining furniture. Wall mounted electric heater, ceiling light and power.

Kitchen

3.0m x 2.6m (9' 10" x 8' 6")

Fitted with a range of base and wall units with contrasting work surfaces over and tiled surrounds. Stainless steel sink and drainer with mixer tap over. Built-in neff oven and microwave. Integrated electric hob with stainless steel extractor hood over. Space and plumbing for white goods. Space for fridge/freezer. Vinyl flooring, ceiling light and power.

Landing

Doors leading to all bedrooms and WC and shower room. Location of loft access. Electric wall heater, fitted carpet and ceiling light.

Fitted with a low level WC. Tiled flooring, ceiling light.

Shower Room

Fitted with a walk-in shower cubicle and wash hand basin set into vanity style unit. Tiled flooring, ceiling light. uPVC opaque window to the rear.



Garden


To the front of the property is a fully enclosed gated garden with a block paved path leading to the front door entrance with a lawned area to the side.





