1 Brief description of damage to the property:

The main area of damage is to the Bay to left side and takes the form of separation between the left side of the bay and the main house along with distortion and cracking.

This pattern of damage indicates a mechanism of Downward and rotational movement to the bay.

The level of damage is slight, and is classified as category 2 in accordance with BRE Digest 251 - Assessment of damage in low-rise buildings.

2 Cause of damage to the property

This is to certify that, as required by our Terms of Appointment, we have appraised the property as regards to the above damage which in our professional opinion has been caused by clay shrinkage subsidence. This has been caused by moisture extraction by roots altering the moisture content of the clay subsoil, resulting in volume changes, which in turn have affected the foundations.

3 Mitigation measures

Mitigation action included removal of the vegetation owned by the policyholder.

The property was monitored by us from 25/06/2019 to 29/11/2019 and found to be stable.

4 Superstructure repairs/redecoration

Repair work has been undertaken to the property. The works consisted generally of superstructure strengthening with the insertion of Helical stainless steel bars, crack repairs and redecorations all as detailed on the attached schedule.
