Summary

Situated in a cul-de-sac within an established residential area of Glenrothes, this twobedroom mid-terraced house enjoys wellpresented interiors and neutral décor throughout. It represents an ideal home for first-time buyers, professionals, couples, and young families. It is accompanied by front and rear gardens and a shared path at the rear (40 inches at the narrowest) servicing 2 and 3 Melrose Place, which leads to a 6ft inward swing gate, allowing access to the rear garden. It also lies within easy reach of amenities in Glenrothes. These include a wealth of shops, including supermarkets and a shopping centre, schooling, transport links (including a train station just a short drive away), and open spaces. 








Floorplan
