Comprises an entrance hall, living/dining room, kitchen, two double bedrooms and a shower room.

Highlights include a modern fitted kitchen, with appliances, and solid wood worktops, a contemporary bathroom suite, and a logburning stove. In addition, there is gas central heating, double glazing, hardwood flooring, an upgraded front door and good storage.

To the rear is a shared drying green, with a private shed, whilst unrestricted parking is available on the surrounding streets.

A spacious entrance hall, with storage, is finished with light, neutral decor and wood-effect flooring. A well-proportioned living room enjoys plenty of natural light from dual-aspect glazing and features a wood-burning stove, with a rustic timber surround. Plenty of space is available for freestanding furniture and the reception room conveniently opens into a kitchen. Fitted with modern units, solid wood worktops and LED plinth lighting, the kitchen includes an integrated oven, a gas hob, a canopy, a freestanding fridge/freezer, a dishwasher and a washing machine.


