## Ground Floor

### Communal Hallway

Main secure entrance with intercom to apartment. Carpeted hallway and stairs to apartment entrance door.

### Entrance Hallway

Front door into hallway. Alarm panel and phone to secure main entrance. All doors leading to accommodation. Fuse box.

### Kitchen/Lounge/Diner

17' 10" x 14' 2" narrowing to 9' 3" (5.44m x 4.32m)  
Two Upvc double glazed windows to rear aspect. Modern kitchen fitted with base and eye level units with roll top work surface over. Built in electric hob with stainless steel extractor over. Sink and drainer unit. Plumbing for washing machine. Space for fridge freezer. Ceramic tiled floor. Wall mounted gas fired combi boiler.

### Bedroom One

15' 2" x 7' 1" (4.62m x 2.16m)  
Frosted Upvc double glazed window to front aspect.

### Family Bathroom

8' 6" x 6' 4" max (2.59m x 1.93m)  
Modern white three piece suite comprising of panelled bath with shower attachment and ceramic tile splash back wall. Low level WC. Wash hand basin with ceramic tile splash back. Ceramic tiled floor. Extractor fan. Built in storage cupboard. Inset spot lights.

Variation of contract at the tenant's request – £50.00 (inc. VAT) per agreed variation.

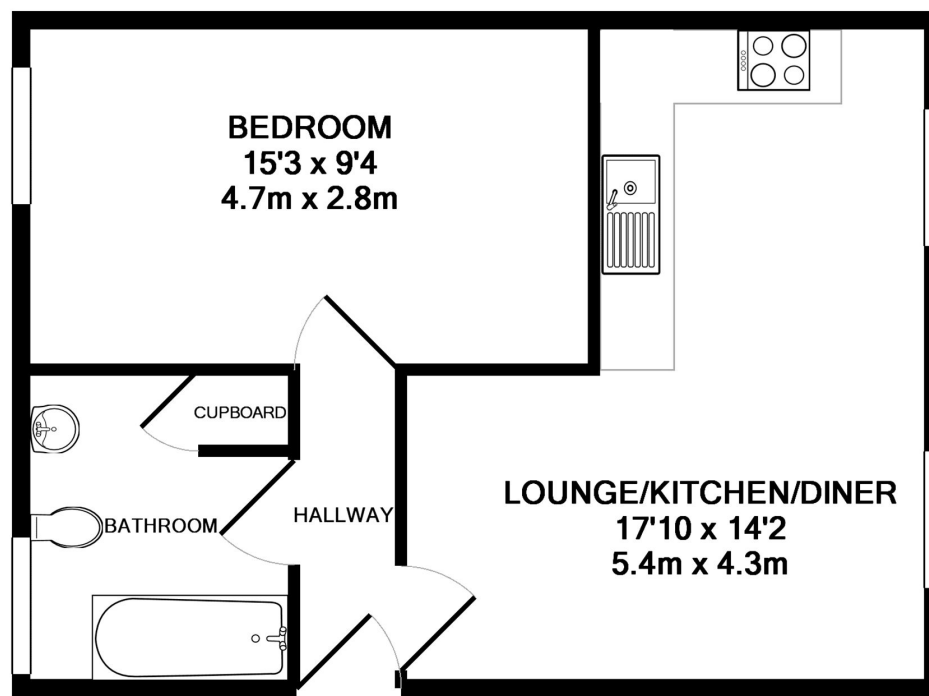
Change of sharer at the tenant's request – £50.00 (inc. VAT) per replacement tenant or any reasonable costs incurred if higher.

Early termination of tenancy at tenant's request – Should the tenant wish to terminated their contract early, they shall be liable to the landlord's costs in re-letting the property as well as all rent due under the tenancy until the start of date of the replacement tenancy. These costs will be no more than the maximum amount of rent outstanding on the tenancy.
