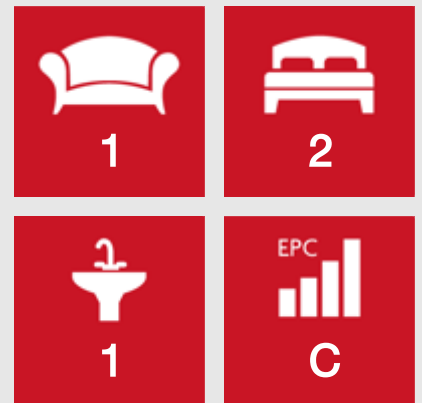

Floorplan

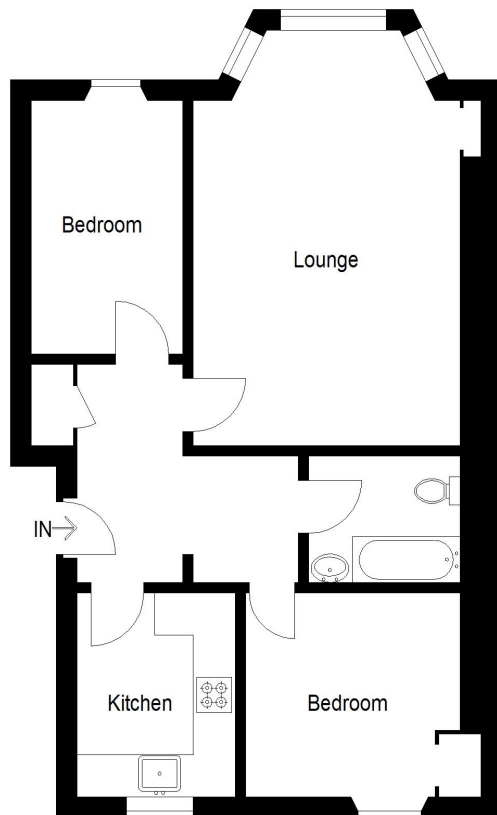
