### Description

A truly unique opportunity to acquire approximately 35.06 acres of mixed pasture, scrubland, and mature woodland situated along Ynysallan Road, on the outskirts of Swansea.

This diverse and natural landscape offers exceptional value for those seeking environmental, conservation, agricultural, or recreational potential.

The land is rich in biodiversity, with varied topography and habitats that may appeal to those interested in rewilding, eco-tourism, carbon offsetting, or nature conservation projects (subject to necessary consents). With a blend of open pasture, naturally regenerating scrub, and established woodland, the site is ideal for sustainable land use or low-impact development schemes.

The land extends to 35.06 acres in total of which 21.83 acres is general scrubland and established mixed broadleaf woodland, with the remaining 10.44 acres being suitable for grazing purposes. 1200 Christmas tree saplings were planted on one field in 2023.

A pending application for an eco glamping site is currently outstanding with the City & County of Swansea Planning Department (see below for full details).

2.80 acres of general scrubland and mixed broadleaf woodland may have further potential for alternative use subject to obtaining planning consents.

#### **Situation**

The land fronts directly onto Ynysallan Road, in the suburban district of Llansamlet, on the outskirts of Swansea, offering excellent transport links to Junction 45 of the M4 which lies approximately 2 miles away.

Set in a quiet yet accessible location, this land offers a rare chance to own a substantial tract of natural Welsh countryside with significant environmental value and long-term potential.

The land is mainly classified as 'Slowly permeable wet acid upland soils with a peaty surface' with a smaller proportion classified as 'Loamy and clayey floodplain soils with naturally high groundwater' according to the Cranfield University Soilscapes map. The land is mainly identified as Grade 3b with a smaller proportion identified as Grade 2 and Grade 3a quality land Welsh Governments Predictive Agricultural Land Classification (ALC) Map 2.

The property is sold subject to and with the benefit of all right of way, easements and wayleaves (if any).

### **Planning**

The land benefits from a pending planning application of the use of disused farmland as an eco-friendly camping site comprising of 12 bell tent glamping pitches situated on decks, wash/toilet blocks, a site office and parking area. Under planning application number 2023/0198/FUL.

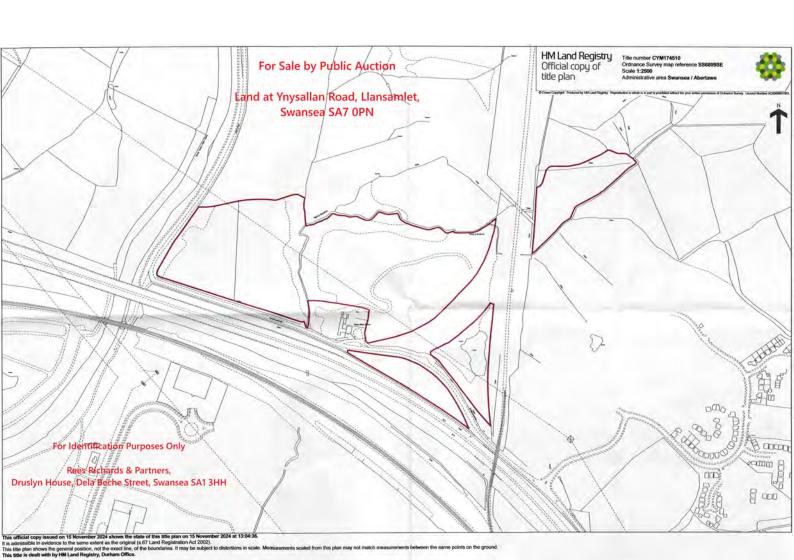

#### **AUCTION CONDUCT CONDITIONS**

1. The catalogue is issued only on the basis that you accept these auction conduct conditions. They govern our relationship with you and cannot be disapplied or varied by the sales conditions (even by a condition purporting to replace the whole of the Common Auction Conditions). They can be varied only if we agree.

## 2. Our Role: -

- 2.1 As agents for each seller we have authority to:
  - a) Prepare the catalogue from information supplied by or on behalf of each seller;
  - b) Offer each lot for sale;
  - c) Sell each lot;
  - d) Receive and hold deposits;
  - e) Sign each sale memorandum, and
  - f) Treat a contract as repudiated if the buyer fails to sign a sale memorandum or pay a deposit as required by these auction conduct conditions.
- 2.2 Our decision on the conduct of the auction is final.
- 2.3 We may cancel the auction, or alter the order in which lots are offered for sale. We may also combine or divide lots. A lot may be sold or withdrawn from sale prior to the auction.
- 2.4 You acknowledge that to the extent permitted by law we owe you no duty of care and you have no claim against us for any loss.

### 3. Bidding and reserve prices: -

- 3.1 All bids are to be made in pounds sterling exclusive of any applicable VAT.
- 3.2 We may refuse to accept a bid. We do not have to explain why.
- 3.3 If there is a dispute over bidding we are entitled to resolve it, and our decision is final.
- 3.4 Unless stated otherwise each lot is subject to a reserve price (which may be fixed just before the lot is offered for sale). If no bid equals or exceeds the reserve price the lot will be withdrawn from the auction.
- 3.5 Where there is a reserve price the seller may bid (or ask us or another agent to bid on the seller's behalf) up to the reserve price but may not make a bid equal to or exceeding the reserve price. 3.6 Where a guide price (or range of prices) is given that guide is the minimum price at which, or range of prices within which, the seller might be prepared to sell at the date of the guide price. #### **PROPERTY AUCTION GUIDELINES**

#### **Sales Particulars**

Particulars for each Lot will contain a Guide Price. Please remember this only represents a view as to where the value may lie.

#### <u>Finance</u>

Should you require finance to purchase a property at Auction, (eg. Mortgage, bank loan, etc) it is advisable to have this arranged with the relevant Bank/Building Society prior to Auction. All lenders will require a survey to be carried out, therefore these can and should be done before the property is sold at auction. If you are a cash buyer, it is also advisable for you have a survey carried out on the property prior to auction, but this is entirely your decision.

#### **Legal Packs**

The vendors solicitor will prepare a legal pack containing copies of Conditions of sale, and all other legal documents, searches, plans, Title deeds, etc for each Lot. The pack will be available at our offices prior to Auction and can be inspected at any time during opening hours. Should you wish for your own copy of these documents, these can be sent by email free of charge, however, should you require a paper copy there will be a charge of £30.00 (inclusive of VAT) per Lot. It is the responsibility of the bidders to verify with the vendors solicitor that the pack they receive is accurate and complete. You buy subject to the terms of the contract and all documentation whether or not you or your solicitor have read them.

## Reserve

All properties placed at Auction will be offered subject to a reserve price. (This figure is usually set by the owner of a particular lot or a solicitor, on the day of the Auction) this is the minimum figure that the property can be sold for.

#### Making a Bid

Our Property Auctions commence <u>promptly</u> so please ensure that you arrive giving yourself plenty of time as all prospective purchasers MUST register their details with our Staff, prior to auction. On completion of the registration you will be given your own unique "Bidding Number". Once the Auction commences, please ensure that your bids are made clear to the Auctioneer. If you are successful in your bid, you will be asked to raise your bidding number so that the information can be logged against that particular Lot. (See additional notes on registration). Bids are accepted on the basis that you have read and understood the auction contract and other documentation comprising the legal pack as supplied by the vendors solicitor.

#### Contracts

On completion of the Property Auction, each successful purchaser will be asked to come forward to sign the relevant documents, and exchange of contracts then takes place. At this stage you will be required to pay a 10 per cent deposit, this can be either cash or cheque (made payable to relevant solicitors acting for that Particular Lot).

## Completion

Usually takes place 28 days after exchange of contracts, at this time the balance of the monies will be required.

#### Registration

In order to comply with Money Laundering Act of 2017, Rees Richards & Partners require all prospective purchasers to register their details with our Staff <u>prior</u> to auction.
