Property Description

Well-presented one bedroom, second floor flat, set to the front of a traditional stone-built tenement, and conveniently located in the popular Gorgie area, west of Edinburgh city centre.

Comprises: an entrance hall, living/dining room, kitchen, double bedroom, utility cupboard, and a bathroom.

Features include a stylish kitchen, bright bathroom, and good integrated storage provision.

In addition, there is gas central heating, double glazing, TV and telephone points, and a secure entry system.

Externally, there is a shared garden to the rear, with unrestricted on-street parking to the front and on surrounding streets.

The hall gives access to all rooms except the kitchen, and features two built-in press cupboards, the entryphone handset, and a utility cupboard housing a washing machine and freezer.

A good-sized public room has space for lounge and dining furniture, and features carpeted flooring, a central pendant light fitting and a press cupboard also housing the central heating unit.

The kitchen is set internally off the lounge, and includes modern fitted units and worktops, a sink with drainer, unit downlighting, a microwave, and an integrated double oven, and gas hob with a canopy above.


A bright and well-proportioned double bedroom features built-in overbed storage cupboards, period cornice-work, carpeted flooring and a central pendant light fitting.

Completing the accommodation, the bathroom is fitted with a three-piece suite, including a shower unit over the bath, tiled flooring and splashwalls.
