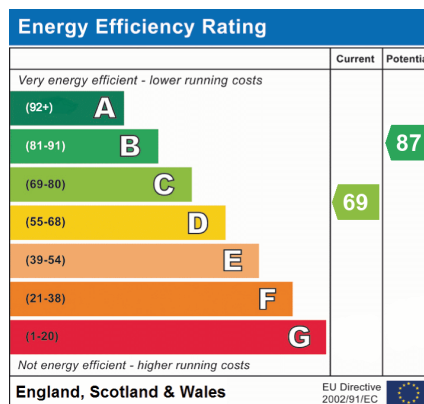
Approximate Gross Internal Area
