Summary

This charming country cottage with self-contained annex is set in generous, mature garden grounds with views over the Esk valley to the Pentland hills. The cottage comprises 3 double bedrooms, utility room, bathroom, kitchen with granite worktops and access to the garden, and living room with multifuel stove. The annex comprises living room with patio doors to the garden, kitchen, double bedroom and shower room. This spacious rural home is within easy reach of local and independent schools, shops, train and bus links, and 30 minutes from Edinburgh and Edinburgh airport. There are nearby woodland walks and cycle paths.


