## **Property Description**

Light and beautifully presented, two-bedroom, ground-floor apartment, with private parking. Forming part of a modern development, just north of the town centre of Kirkcaldy, Fife.

Comprises an entrance hallway, open plan living/dining room and kitchen, two double bedrooms, an en-suite shower room, and a bathroom.

Highlights include a stylish kitchen with appliances, modern bathroom suites, contemporary flooring, and light neutral decor. In addition, there is double glazing, gas central heating, and a secured entry system.

This well-maintained development also includes a shared green and a private off-street residential car park.


A welcoming entrance hall affords access throughout the property, including a large convenient built-in cupboard. Set to the front, a spacious open-plan living/dining room and kitchen features light decor, wood effect flooring throughout, and a Juliet balcony for the lounge. Set to the rear of the room, the kitchen is fitted with wall and base units, a sink with a drainer, an oven, a gas hob, and a freestanding washing machine and fridge/freezer.

Set to the rear, a tastefully finished master bedroom includes carpeted flooring, ample space for furnishings and a modern en-suite shower room. A further carpeted bedroom is also set to the southerly-facing rear and features a built-in wardrobe. Completing the accommodation, the bathroom is set internally off the hall, with a modern three-piece suite including a shower over the bath and tiled splash walls.
